This RFP is conducted in accordance with the UNDP Programme and Operations Policies and Procedures (POPP) on Contracts and Procurement which can be accessed at https://popp.undp.org/SitePages/POPPBSUnit.aspx?TermID=254a9f96-b883-476a-8ef8-e81f93a2b38d</p> <p>1.2 Any Proposal submitted will be regarded as an offer by the Bidder and does not constitute or imply the acceptance of the Proposal by UNDP. UNDP is under no obligation to award a contract to any Bidder as a result of this RFP.</p> <p>1.3 As part of the bid, it is desired that the Bidder registers at the United Nations Global Marketplace (UNGM) website (www.ungm.org). The Bidder may still submit a bid even if not registered with the UNGM. However, if the Bidder is selected for contract award, the Bidder must register on the UNGM prior to contract signature.</p>

Vendors are therefore required to disclose to UNDP whether they are subject to any sanction or temporary suspension imposed by these organizations.</p> <p>3.2 It is the Bidder's responsibility to ensure that its employees, joint venture members, sub-contractors, service providers, suppliers and/or their employees meet the eligibility requirements as established by UNDP.</p>

4. Conflict of Interests	<p>4.1 Bidders must strictly avoid conflicts with other assignments or their own interests, and act without consideration for future work. Bidders found to have a conflict of interest shall be disqualified. B. PREPARATION OF PROPOSALS	
5. General Considerations	<p>5.1 In preparing the Proposal, the Bidder is expected to examine the RFP in detail. Material deficiencies in providing the information requested in the RFP may result in rejection of the Proposal.</p> <p>5.2 The Bidder will not be permitted to take advantage of any errors or omissions in the RFP. Should such errors or omissions be discovered, the Bidder must notify the UNDP</p>
6. Cost of Preparation of Proposal	<p>6.1 The Bidder shall bear any and all costs related to the preparation and/or submission of the Proposal, regardless of whether its Proposal was selected or not. UNDP shall not be responsible or liable for those costs, regardless of the conduct or outcome of the procurement process.</p>
7. Language	<p>7.1 The Proposal, as well as any and all related correspondence exchanged by the Bidder and UNDP, shall be written in the language (s) specified in the BDS.</p>
8. Documents	<p>8.1 The Proposal shall comprise of the following documents:</p>

Comprising the Proposal	<ul style="list-style-type: none"> a) Documents Establishing the Eligibility and Qualifications of the Bidder; b) Technical Proposal; c) Financial Proposal; d) Proposal Security, if required by BDS; e) Any attachments and/or appendices to the Proposal.
9. Documents Establishing the Eligibility and Qualifications of the Bidder	<p>9.1 The Bidder shall furnish documentary evidence of its status as an eligible and qualified vendor, using the Forms provided under Section 6 and providing documents required in those forms. In order to award a contract to a Bidder, its qualifications must be documented to UNDP's satisfaction.</p>
10. Technical Proposal Format and Content	<p>10.1 The Bidder is required to submit a Technical Proposal using the Standard Forms and templates provided in Section 6 of the RFP.</p> <p>10.2 The Technical Proposal shall not include any price or financial information. A Technical Proposal containing material financial information may be declared non-responsive.</p> <p>10.3 Samples of items, when required as per Section 5, shall be provided within the time specified and unless otherwise specified by UNDP, and at no expense to UNDP</p> <p>10.4 When applicable and required as per Section 5, the Bidder shall describe the necessary training programme available for the maintenance and operation of the services and/or equipment offered as well as the cost to the UNDP. Unless otherwise specified, such training as well as training materials shall be provided in the language of the Bid as specified in the BDS.</p>
11. Financial Proposals	<p>11.1 The Financial Proposal shall be prepared using the Standard Form provided in Section 6 of the RFP. It shall list all major cost components associated with the services, and the detailed breakdown of such costs.</p> <p>11.2 Any output and activities described in the Technical Proposal but not priced in the Financial Proposal, shall be assumed to be included in the prices of other activities or items, as well as in the final total price.</p> <p>11.3 Prices and other financial information must not be disclosed in any other place except in the financial proposal.</p>
12. Proposal Security	<p>12.1 A Proposal Security, if required by BDS, shall be provided in the amount and form indicated in the BDS. The Proposal Security shall be valid up to thirty (30) days after the final date of validity of the Proposal.</p> <p>12.2 The Proposal Security shall be included along with the Technical Proposal. If Proposal Security is required by the RFP but is not found along with the Technical Proposal, the Proposal shall be rejected.</p> <p>12.3 If the Proposal Security amount or its validity period is found to be less than what is required by UNDP, UNDP shall reject the Proposal.</p> <p>12.4 In the event an electronic submission is allowed in the BDS, Bidders shall include a copy of the Bid Security in their proposal and the original of the Proposal Security must be sent via courier or hand delivery as per the instructions in BDS.</p> <p>12.5 The Proposal Security may be forfeited by UNDP, and the Proposal rejected, in the event of any one or combination, of the following conditions:</p> <ul style="list-style-type: none"> a) If the Bidder withdraws its offer during the period of the Proposal Validity specified in the BDS, or; b) In the event that the successful Bidder fails:

	<p>i. to sign the Contract after UNDP has issued an award; or</p> <p>12.6 to furnish the Performance Security, insurances, or other documents that UNDP may require as a condition precedent to the effectivity of the contract that may be awarded to the Bidder.</p>
13. Currencies	<p>13.1 All prices shall be quoted in the currency or currencies indicated in the BDS. Where Proposals are quoted in different currencies, for the purposes of comparison of all Proposals:</p> <p>a) UNDP will convert the currency quoted in the Proposal into the UNDP preferred currency, in accordance with the prevailing UN operational rate of exchange on the last day of submission of Proposals; and</p> <p>b) In the event that UNDP selects a proposal for award that is quoted in a currency different from the preferred currency in the BDS, UNDP shall reserve the right to award the contract in the currency of UNDP's preference, using the conversion method specified above.</p>
14. Joint Venture, Consortium or Association	<p>14.1 If the Bidder is a group of legal entities that will form or have formed a Joint Venture (JV), Consortium or Association for the Proposal, they shall confirm in their Proposal that : (i) they have designated one party to act as a lead entity, duly vested with authority to legally bind the members of the JV, Consortium or Association jointly and severally, which shall be evidenced by a duly notarized Agreement among the legal entities, and submitted with the Proposal; and (ii) if they are awarded the contract, the contract shall be entered into, by and between UNDP and the designated lead entity, who shall be acting for and on behalf of all the member entities comprising the joint venture.</p> <p>14.2 After the Deadline for Submission of Proposal, the lead entity identified to represent the JV, Consortium or Association shall not be altered without the prior written consent of UNDP.</p> <p>14.3 The lead entity and the member entities of the JV, Consortium or Association shall abide by the provisions of Clause 9 herein in respect of submitting only one proposal.</p> <p>14.4 The description of the organization of the JV, Consortium or Association must clearly define the expected role of each of the entity in the joint venture in delivering the requirements of the RFP, both in the Proposal and the JV, Consortium or Association Agreement. All entities that comprise the JV, Consortium or Association shall be subject to the eligibility and qualification assessment by UNDP.</p> <p>14.5 A JV, Consortium or Association in presenting its track record and experience should clearly differentiate between:</p> <p>a) Those that were undertaken together by the JV, Consortium or Association; and</p> <p>b) Those that were undertaken by the individual entities of the JV, Consortium or Association.</p> <p>14.6 Previous contracts completed by individual experts working privately but who are permanently or were temporarily associated with any of the member firms cannot be claimed as the experience of the JV, Consortium or Association or those of its members, but should only be claimed by the individual experts themselves in their presentation of their individual credentials.</p> <p>14.7 JV, Consortium or Associations are encouraged for high value, multi-sectoral requirements when the spectrum of expertise and resources required may not be available within one firm.</p>

15. Only One Proposal	<p>15.1 The Bidder (including the individual members of any Joint Venture) shall submit only one Proposal, either in its own name or as part of a Joint Venture.</p> <p>15.2 Proposals submitted by two (2) or more Bidders shall all be rejected if they are found to have any of the following:</p> <ul style="list-style-type: none"> a) they have at least one controlling partner, director or shareholder in common; or b) any one of them receive or have received any direct or indirect subsidy from the other/s; or c) they have the same legal representative for purposes of this RFP; or d) they have a relationship with each other, directly or through common third parties, that puts them in a position to have access to information about, or influence on the Proposal of, another Bidder regarding this RFP process; e) they are subcontractors to each other's Proposal, or a subcontractor to one Proposal also submits another Proposal under its name as lead Bidder; or f) some key personnel proposed to be in the team of one Bidder participates in more than one Proposal received for this RFP process. This condition relating to the personnel, does not apply to subcontractors being included in more than one Proposal.
16. Proposal Validity Period	<p>16.1 Proposals shall remain valid for the period specified in the BDS, commencing on the Deadline for Submission of Proposals. A Proposal valid for a shorter period may be rejected by UNDP and rendered non-responsive.</p> <p>16.2 During the Proposal validity period, the Bidder shall maintain its original Proposal without any change, including the availability of the Key Personnel, the proposed rates and the total price.</p>
17. Extension of Proposal Validity Period	<p>17.1 In exceptional circumstances, prior to the expiration of the proposal validity period, UNDP may request Bidders to extend the period of validity of their Proposals. The request and the responses shall be made in writing, and shall be considered integral to the Proposal.</p> <p>17.2 If the Bidder agrees to extend the validity of its Proposal, it shall be done without any change in the original Proposal.</p> <p>17.3 The Bidder has the right to refuse to extend the validity of its Proposal, and in which case, such Proposal will not be further evaluated.</p>
18. Clarification of Proposal	<p>18.1 Bidders may request clarifications on any of the RFP documents no later than the date indicated in the BDS. Any request for clarification must be sent in writing in the manner indicated in the BDS. If inquiries are sent other than specified channel, even if they are sent to a UNDP staff member, UNDP shall have no obligation to respond or confirm that the query was officially received.</p> <p>18.2 UNDP will provide the responses to clarifications through the method specified in the BDS.</p> <p>18.3 UNDP shall endeavor to provide responses to clarifications in an expeditious manner, but any delay in such response shall not cause an obligation on the part of UNDP to extend the submission date of the Proposals, unless UNDP deems that such an extension is justified and necessary.</p>
19. Amendment of Proposals	<p>19.1 At any time prior to the deadline of Proposal submission, UNDP may for any reason, such as in response to a clarification requested by a Bidder, modify the RFP in the form of an amendment to the RFP. Amendments will be made available to all prospective bidders.</p>

	19.2	If the amendment is substantial, UNDP may extend the Deadline for submission of proposal to give the Bidders reasonable time to incorporate the amendment into their Proposals.
20. Alternative Proposals	20.1	Unless otherwise specified in the BDS, alternative proposals shall not be considered. If submission of alternative proposal is allowed by BDS, a Bidder may submit an alternative proposal, but only if it also submits a proposal conforming to the RFP requirements. UNDP shall only consider the alternative proposal offered by the Bidder whose conforming proposal ranked the highest as per the specified evaluation method. Where the conditions for its acceptance are met, or justifications are clearly established, UNDP reserves the right to award a contract based on an alternative proposal.
	20.2	If multiple/alternative proposals are being submitted, they must be clearly marked as "Main Proposal" and "Alternative Proposal"
21. Pre-Bid Conference	21.1	When appropriate, a Bidder's conference will be conducted at the date, time and location specified in the BDS. All Bidders are encouraged to attend. Non-attendance, however, shall not result in disqualification of an interested Bidder. Minutes of the Bidder's conference will be disseminated on the procurement website and shared by email or on the e-Tendering platform as specified in the BDS. No verbal statement made during the conference shall modify the terms and conditions of the RFP, unless specifically incorporated in the Minutes of the Bidder's Conference or issued/posted as an amendment to RFP.

22. Submission	22.1	The Bidder shall submit a duly signed and complete Proposal comprising the documents and forms in accordance with the requirements in the BDS. The submission shall be in the manner specified in the BDS.
	22.2	The Proposal shall be signed by the Bidder or person(s) duly authorized to commit the Bidder. The authorization shall be communicated through a document evidencing such authorization issued by the legal representative of the bidding entity, or a Power of Attorney, accompanying the Proposal.
	22.3	Bidders must be aware that the mere act of submission of a Proposal, in and of itself, implies that the Bidder fully accepts the UNDP General Contract Terms and Conditions.

A. PROJECT TITLE

Assessment of public opinion towards migration and potential of migrants to contribute to local development in UNDP/MiDL Project target communities

B. PROJECT DESCRIPTION

General Background:

Migration remains an overwhelming issue in the Republic of Moldova; with a decisive impact both, at national and local level. According to various sources, overall 1/4 of the country's population is still residing abroad. The rural area of the country is particularly affected, as it loses its economically active population in favour of international labour migration and with it, its long-term development perspective. On the other side, remittances continue to make a difference and create significant dependence.

The Moldovan Government (GoM) acknowledges that, if addressed and managed properly, human mobility can also bring many opportunities, changes and improvements in the country. Due to the Swiss development support, the GoM migration policy focus shifted from a management and control perspective to capitalizing on the opportunities provided by migration.

Within the period of 2015-2018, with the support of SDC and UNDP, the Moldovan Government succeeded to successfully devise, enhance and spill over an innovative and effective tailor-made national DMD model of migrants' engagement into local development process, pursuing the improvement of basic local services, creating jobs and income generating activities. Within the piloting phase, 38 communities (representing over 10% of the country population and located in all regions of Moldova) have been supported to pioneer a new DMD model, which resulted in improved local infrastructure and local services with tangible benefit for over 310,000 citizens.

Building on the positive experience from 2016-2018, a new 4-year (2019-2022) phase of the 'Migration and Local Development Project' was launched in January 2019, to be implemented by UNDP with the financial support from the Swiss Agency for Development and Cooperation.

The Overall Goal of this project *is maximizing the impact of migration on the socio-economic development through an improved institutional framework and engaged Diaspora*. In this context, the project shall pursue two Outcomes: *Outcome 1: Moldovan labour, potential, actual and returning migrants benefit from comprehensive employment support services; Outcome 2: Community members, including migrants are meaningfully engaged in the local development process.*

Under Outcome 1, the project will ensure that Moldovan labour, potential, actual and returning migrants benefit from comprehensive employment support services. To that end, national and local authorities will be fully equipped to answer to the needs of all categories of migrants at each stage of migration (pre, migration, post).

Under Outcome 2, actions will warrant that community members, including migrants are meaningfully engaged in the local development process. In line with that, activities will focus on working close with public authorities, other local actors and migrants for the effective implementation of local development initiatives aimed at improving local services and offering income-generating opportunities at local level.

In line with the above, UNDP/UNDP/MiDL Project seeks an experienced specialized company to design and carry out an assessment (including a baseline study and an end line study) in order to measure the changes produced by the UNDP/MiDL Project in the target 35 communities (the list is attached in Annex 1).

C. SCOPE OF SERVICES, EXPECTED OUTPUTS AND TARGET COMPLETION

UNDP/MiDL seeks a specialized company (hereinafter Service Provider) that has the capacity to develop a suitable assessment methodology and to further conduct the assessment in target localities in order to identify local population and migrants' readiness to participate and engage in the improvement of local economic conditions, local public services and satisfaction with the local public service provision, as well as with the individual projects implemented at local level. The assessment shall measure first the baseline situation in the target communities and then the impact (end line) of the activities implemented within the UNDP/MiDL project on these target communities. The baseline assessment shall be conducted in the beginning of the UNDP/MiDL project (Sep 2019) while the end line assessment must be conducted six months before the end of the UNDP/MiDL project (Jul 2019). The Service Provider shall measure the changes in the target communities as a result of the UNDP/MiDL project implementation against clear and comparable indicators.

The **objectives** of the **assessment survey** and its analysis are as follows:

1. Assess the public attitudes, perceptions and behaviour towards migration and potential migrants' contribution in the UNDP/MiDL target communities as compared to the beginning and to the end of the project;
2. Assess perception of LPAs and migrants from UNDP/MiDL target communities towards each other's role in the local development as compared to the beginning and to the end of the project;
3. Assess the degree of citizen satisfaction with the quality of public services, including improved/extended/created services with UNDP/MiDL support as compared to the beginning and to the end of the project;
4. Overview and assessment of local government performance in the studied communities;
5. Provide comparative analysis of data and emphasize trends to enable measuring project progress, as well as evaluate the generated outputs, outcomes and impact (at the project objectives, intermediate results levels).
6. Asses the local economic environment, in particular the relation between the local public authorities and local economic agents, as well as the readiness to engage in this process.

In the long run, the survey should represent an important source of information for the UNDP/MiDL project in the establishment and functioning of a monitoring and evaluation system of the UNDP/MiDL activities at local level.

While performing the tasks, the Service Provider will make the best to avoid duplications and ensure synergy with previous UNDP work, existing research and programmes in this area.

The Service Provider will be responsible for the following **tasks**:

Task 1. Development of the survey methodology

The Service Provider will propose the most appropriate methodology to be applied for achieving the objectives of the assessment survey. The Service Provider will ensure that the methodological approach and that data will be comparable and includes a description of the survey sampling.

The project has selected from nearly 70 applications throughout the entire territory of Moldova 35 target localities with a total of ~ 250 000 people where ~22-25% are migrants. The project is supporting target LPAs in mainstreaming migration in local planning processes, both at the institutional (local migration focal points designated) and policy (local socio-economic strategies updated) levels and improving basic local public services with migrants' support and contribution. The LPAs supported migrants in setting up 35 Home Town Associations that engage international and internal migrants in addressing the communities' needs.

The Service Provider will propose to UNDP/MiDL project a **work methodology** of selecting a representative sample from the 35 UNDP/MiDL target communities that will be representative for the studied population. The data should offer comparative grounds for comparative analysis.

The sampling methodology will be done to ensure that the survey sample includes beneficiaries/potential users of local development, concrete public services, as per projects implemented with UNDP/MiDL support at local level. The survey target group shall be represented by the adult population, while the sample shall take into account the population size, sex, age, social groups, ethnicity, etc. A special set of questions on these public services should be elaborated and included in the survey questionnaire.

The assessment might include both quantitative methods of data collection (survey with general population) and qualitative (focus groups with migrants and interviews with all LPAs from target communities).

The data collection tools may include, but not be limited to the following topics:

- (1) citizen perceptions of communication with LPAs, perceived influence on the decision making process, local government openness and transparency towards migration and potential migrants' contribution;
- (2) citizen attitudes towards LPAs actions in engaging with community members, including migrants, promoting know-how transfer from abroad with a view to improving local development, essential services and offering opportunities for income-generating activities;
- (3) citizen attitudes, perceptions and behaviour towards migration in the community, potential migrants' contribution and relationship with the migrants;
- (4) LPAs and migrants' attitudes, perceptions and behaviour towards each other's role in the local development process;
- (5) the mechanisms for enabling transparent, representative and accountable LPAs towards migrants and non-migrants, as well as the experiences and perceptions of citizens on these issues;
- (6) citizen satisfaction with the local economic development, quality of public services provided locally, including improved/extended/created services with UNDP/MiDL support; main issues/problems related to the provision of local public services, willingness to pay for the services, social media, Home Town Associations; including migrants needs for additional services from LPAs;
- (7) local government performance and outputs or results achieved in service delivery, income and expenditure.

The TASK 1 of the assignment includes the preparatory work in setting up the methodology for the assessment study and the implementation plan to carry out the activities within the assessment study.

The expected **outputs** to be produced for TASK 1 will include:

- a) Assessment methodology, including detailed sampling for both quantitative and qualitative data collection methods;
- b) Data collection (questionnaires, interview guides, etc.)
- c) Final Report Outline

d) Detailed timeframe

To ensure the quality of the data collection, the Service Provider will make sure that interviewers – both for quantitative and qualitative data collection methods – are sufficient in number, qualified to conduct the survey professionally in an objective and unbiased manner and able to address the sensitivities of the sampling size.

TASK 2: Data collection in target localities for the baseline and impact (end line) assessment

This task will include the following:

- 2.1 Set up and manage the data collection through the fieldwork activities on the basis of the agreed methodology, sample size and designed tools;
- 2.2 Develop an appropriate database for data entry;
- 2.3 Ensure quality of field work/data collection and data entry;
- 2.4 Analyse the results – data control, processing and producing of statistical annexes (tables and diagrams), data analysis in the form of a report, drafting of conclusions, recommendations and follow-up activities;
- 2.5 Produce the final Report and presentation of draft and final versions (in both Romanian and English).

The expected **outputs** to be produced for TASK 2 will include:

I. Copies of Data collection tools, Survey/interview/focus groups Responses, Database

All hard and digital files related to the Survey: (i) interview questionnaire not exceeding 5 pages; (ii) responses collected within the survey and recorded in a database, including in electronic format agreed with UNDP/MiDL/UNDP; and (iii) other related tables and graphics and instructions for accessing, extracting and using the data.

The results of the assessment will become the property of UNDP and will be for internal use, thus they should not be used without permission of UNDP.

II. Assessment Reports

Two reports shall be produced: the baseline report in the beginning of the project and the end line report six months before the end of the project. The reports should have up to 30 pages each and meet the objectives required and cover the contents indicated above. The reports must be produced in both Romanian and English and provided as hard and electronic copy. Each report shall contain a presentation and analysis of the assessment results, as per the assessment objectives.
