Initially, individual consultants will be short-listed based on the following minimum qualification criteria:

- University Degree (5-year university education) in Law, Law Enforcement/Police Studies, Security Studies or another relevant field;
- At least 5 years of professional experience in the area of internal/home affairs, police administration/management or law enforcement;
- Minimum two feasibility comprehensive studies developed in the area of internal/home affairs, police administration/management or law enforcement.

The screening shall be a desk review of application packages. Therefore, applicants are advised to highlight their compliance to notice requirements through including relevant information in the supporting documentation (CV, motivation letter, etc.)

## \*2. Academic Qualifications

# **2.4 Section 4. Evaluation - Technical and Interview Stage**

#### 1. Cumulative analysis

The short-listed individual consultants will be evaluated based on the following methodology: Cumulative analysis.

The award of the contract shall be made to the individual consultant whose offer has been evaluated and determined as:

- a) responsive/ compliant/ acceptable, and
- b) having received the highest score out of a pre-determined set of weighted technical and financial criteria specific to the solicitation.
- \* Technical Criteria weight 60% (300 pts);



\* Financial Criteria weight – 40% (200 pts).

Only candidates obtaining a minimum of 210 points would be considered for the Financial Evaluation.

# \*2. Evaluation criteria - Technical Stage

- 1. University Degree in Law, Law Enforcement/Police Studies, Security Studies or another relevant field Master's 5 pts; PhD –10 pts
- 2. Professional experience in the area of internal/home affairs, police administration / management or law enforcement (at least 5 years)

Up to 5 years - 0 points, 5 years - 5 points, each additional year - 5 points up to max. 25 pts

- 3. Demonstrated experience in elaboration of feasibility studies in the area of internal/home affairs police administration/management or law enforcement (minimum two comprehensive studies)
  Up to two comprehensive studies- 0 points, two studies 10 points, each additional study / project 10 pts. Up to max. 50 pts
- 4. Professional experience in Central and Eastern Europe on similar assignments is desirable Each assignment 5 pts, up to max 15 pts (3 assignments)
- 5. Experience in working with UN agencies is an asset Each assignment 5 pts, up to max 15 pts (3 assignments) Response attachments are optional.

## \*3. Evaluation criteria - Interview Stage

- 1. Proven competencies in carrying out needs and capacity assessments; designing feasibility studies/documentation/ specific regulatory framework/ standard operating procedures
  Limited competencies 5 pts, fair competences up to 15 pts., good competences up to 30 pts, very good up to 40 pts
- 2. Strong understanding and knowledge of modern technical solutions and methodologies related to renovation and efficient operation of the shooting range infrastructure

  Limited up to 5 pts, fair up to 25 pts., good up to 45 pts, very good up to 65 pts
- 3. Solid understanding of and ability to apply communication and collaboration tools and techniques (MS Office 365, ZOOM, Google tools etc.), including the ability to analyses and use research data outside from the evaluated context

Limited understanding and ability - up to 5 pts., satisfactory - up to 15 pts.; extensive - up to 20 pts

- 4. Resourcefulness and creativity Up to 15 pts
- 5. Strong communication and interpersonal skills Up to 15 pts.
- 6. Command of English language
  Working knowledge / intermediate up to 15 pts, advanced up to 20 pts



7. Additional languages: knowledge of Romanian and/or Russian – 5 pts per language, max. total 10 pts. *Response attachments are optional.* 

# 2.5 Section 5. Evaluation - Financial Stage

#### 1. Financial Evaluation

Evaluation of submitted financial offers will be done based on the following formula:

S = Fmin / F \* 200

S – score received on financial evaluation;

Fmin – the lowest financial offer out of all the submitted offers qualified over the technical evaluation round;

F – financial offer under consideration
