- University Degree (5-year university education) in Social Sciences, Law Enforcement or another relevant field;
- At least 1 year of professional experience in the area of internal/home affairs, police administration/management, law enforcement or criminal justice.

The screening shall be a desk review of application packages. Therefore, applicants are advised to highlight their compliance to notice requirements through including relevant information in the supporting documentation (CV, motivation letter, etc.)

### **\*2. Minimum Qualification Requirements**

Please indicate whether you meet the below requirements:

- University Degree (5-year university education) in Social Sciences, Law Enforcement or another relevant field;
- At least 1 year of professional experience in the area of internal/home affairs, police administration / management, law enforcement or criminal justice.

## **2.4 Section 4. Evaluation - Technical and Interview Stage**

### **1. Cumulative analysis**

The short-listed individual consultants will be evaluated based on the following methodology: Cumulative analysis.

The award of the contract shall be made to the individual consultant whose offer has been evaluated and determined as:

- a) responsive/ compliant/ acceptable, and
- b) having received the highest score out of a pre-determined set of weighted technical and financial criteria specific to the solicitation.

\* Technical Criteria weight – 60% (300 pts);

\* Financial Criteria weight – 40% (200 pts).

Only candidates obtaining a minimum of 210 points would be considered for the Financial Evaluation.

University Degree – 10 pts; Masters – 15 pts; PhD – 20 pts
2. Professional experience in the area of internal/home affairs, police administration/management, law enforcement or criminal justice (at least 1 year)  
Up to 1 years – 0 points, 1 year – 10 points, each additional year – 10 points up to max. 30 pts
3. Experience in international assistance projects is an asset  
One assignment – 10 pts, each additional assignment – 5 pts, up to max 30 pts (5 assignments)

**\*3. Evaluation criteria - Interview Stage**

1. Experience in cooperation/consultation with Governmental Institutions, and International Organizations  
Limited experience – 5 pts, fair experience – up to 15 pts., good experience – up to 20 pts, very good – up to 25 pts
2. Good organization and drafting skills, ability to work under tight deadlines  
Limited - 5 pts; satisfactory - 10 pts; strong - up to max 20 pts
3. Solid understanding of and ability to apply communication and collaboration tools and techniques (MS Office 365, ZOOM, Google tools etc.), including the ability to analyses and use research data  
Limited understanding and ability - up to 5 pts., satisfactory – up to 20 pts.; extensive – up to 30 pts
4. Demonstrated knowledge of the Internal Affairs/Police reform processes in the Republic of Moldova  
Limited understanding and ability - up to 10 pts., satisfactory – up to 20 pts.; extensive – up to 40 pts
5. Good command of Romanian and English languages for the purposes of the assignment  
Romanian: Working knowledge / intermediate – 10 pts, advanced – up to 20 pts;  
English: Working knowledge / intermediate – 10 pts, advanced – up to 20 pts
6. Resourcefulness, flexibility and punctuality  
Limited - 5 pts; satisfactory - 10 pts; good- 20 pts; extensive - up to max 30 pts
7. Strong communication and interpersonal skills  
Limited - 5 pts; satisfactory - 10 pts; strong / good- 20 pts; extensive - up to max 30 pts
8. Belonging to the group(s) under-represented in the UN Moldova and/or the area of assignment\*
