

#### **TERMS OF REFERENCE**

**A. Job Title:** National Consultant on Left bank (of Nistru River) economic sector analysis and CBM promotion

**B. Duty Station:** Home based

**C. Project reference:** EU Confidence Building Measures Programme (EU CBM 6)

**D. Contract type:** Individual Contract (IC)

**E. Duration of assignment:** up to 120 working days, in the period of June 2024 – December 2025

## F. Background:

The <u>overall objective</u> of the EU CBM 6 Programme is to contribute to improved confidence between communities on both banks of the Nistru River, through joint initiatives involving local communities, civil society organisations, business actors and other stakeholders. The Programme has 4 major components: 1) Economic development and decent job creation for women and men; 2) Enhanced cross-river thematic cooperation between the civil society from both banks; 3) Community Development and small-scale social infrastructure support; 4) Promotion of Cultural heritage.

### G. Objective:

The main objective of the consultant is to conduct analysis of the current situation of certain sectors of left bank of Nistru river economy, provide recommendations for improvements of EU CBM supported 6 cross-river thematic platforms activities as well as gather relevant data for EU CBM reports.

### H. Scope of work and expected outputs:

Under the guidance of the Programme Manager, the Consultant is expected to perform the following tasks:

- Identify the needs, gather statistical data and develop analytical reports of socio-economic situation on the left bank in following sectors: Health, Environment, Education, Culture, Sport, Tourism;
- Conduct analysis of previous and current activities of 6 EU CBM Cross River Sectoral Platforms, provide set of recommendations to increase Platforms efficiency and effectiveness;
- Provide materials annual progress reports of the EU CBM Programme including data on left bank interventions' results, lessons learned, stakeholders' contributions and media coverage of Programme activities.

### J. Organizational Setting:

The National Consultant will work under the direct supervision of the EU CBM 6 Programme Manager.

### K. Financial arrangements:

The financial proposal shall specify a total **lump sum** amount, and payment terms around specific and measurable (qualitative and quantitative) deliverables (i.e. whether payments fall in instalments or upon completion of the entire contract). Payments are based upon output, i.e. upon delivery of the services specified in the TOR. In order to assist the requesting unit in the comparison of financial proposals, the financial proposal will include a breakdown of this lump sum amount (including the daily fee, taxes, and number of anticipated working days).

#### Travel

No travel was envisaged during the assignment. In the case of unforeseeable travel, payment of travel costs including tickets, lodging, and terminal expenses should be agreed upon, between the respective business unit and Individual Consultant, prior to travel and will be reimbursed.

### L. Confidentiality

Materials provided to the Consultant and all proceedings within the consultancy contract shall be regarded as confidential, both during and after the consultancy. Violation of confidentiality requirements may result in immediate termination of the contract.

## Academic Qualifications:

- Bachelor's degree in management, economics, the social sciences, and humanities, or other relevant areas;
- Master's or Ph.D. degree will be an asset.

# II. Years and sphere of experience:

- At least five years of experience in development programs/projects as well as in interacting with SMEs, NGOs.
- A good understanding of the context of work on the left bank of the Nistru river and the nuances of interaction with local representatives of the business community;
- Experience in working with women-led associations and promoting gender equality.

# III. Competencies:

- Experience in projects with the principles of confidence-building measures;
- In-depth understanding of the region's economic development as well as confidence-building measures;
- Good understanding of the specifics of work on the left bank of the Nistru river;
- Expertise in Trade and Economic Development;
- Knowledge of Gender and Social Inclusion;
- Strong analytical skills and ability to interpret data;

- Ability to conduct thorough research and analysis;
- Skills of effective communication with different categories of the population, including representatives of local administrations, NGOs and the media, business associations, chambers of commerce and industry, and enterprises;
- Excellent command of the Russian language, including excellent skills in preparing text materials in Russian. Proficiency in Romanian and English language is a plus;
- Computer skills, ability to use office equipment, effective use of information technology and tools.

### IV. Interpersonal Skills:

- Resourcefulness and creativity;
- Strong communication and relation-building skills;
- Ability to collaborate and work effectively in a team;
- Excellent problem-solving and decision-making abilities;
- Strong organizational and time management skills;
- Attention to detail and ability to meet deadlines;
- Adaptability and flexibility in a fast-paced environment.

  - The Financial Proposal shall be additionally submitted directly in the system. Please ensure there are no mathematical errors and that amounts from Offeror's Letter to UNDP Confirming Interest and Availability match with your offer in the system.
- Proposal (Motivation Letter): explaining why he/ she is the most suitable candidate for the assignment, including previous experience.
- Duly completed and updated personal CV and at least three (3) references.

**Important notice:** The applicants who have the statute of Government Official / Public Servant prior to appointment will be asked to submit the following documentation:

- a no-objection letter in respect of the applicant received from the Government, and;
- the applicant is certified in writing by the Government to be on official leave without pay for the entire duration of the Individual Contract.

#### O. Evaluation

At first, individual consultants will be selected according to the following minimum qualification criteria:

- Bachelor's degree in management, the social sciences and humanities, or other relevant related areas;
- At least five years of experience in developing programs/projects (targeting local communities development and non-governmental and associative sector) on the left bank.

Thus, selected individual consultants will then be further assessed according to the following methodology:

# **Cumulative analysis**

The contract will be awarded to the individual consultant whose proposal was assessed and defined as:

- a) clear/appropriate/acceptable, and
- b) which obtained the highest score according to the weighted technical and financial criteria, formulated for this request.
  - \* Specific weight of technical criteria 60% (300 p.);
  - \* Specific weight of financial criteria 40% (200 p.).

Only candidates who scored a minimum of 210 p. are allowed to participate in the financial assessment.
