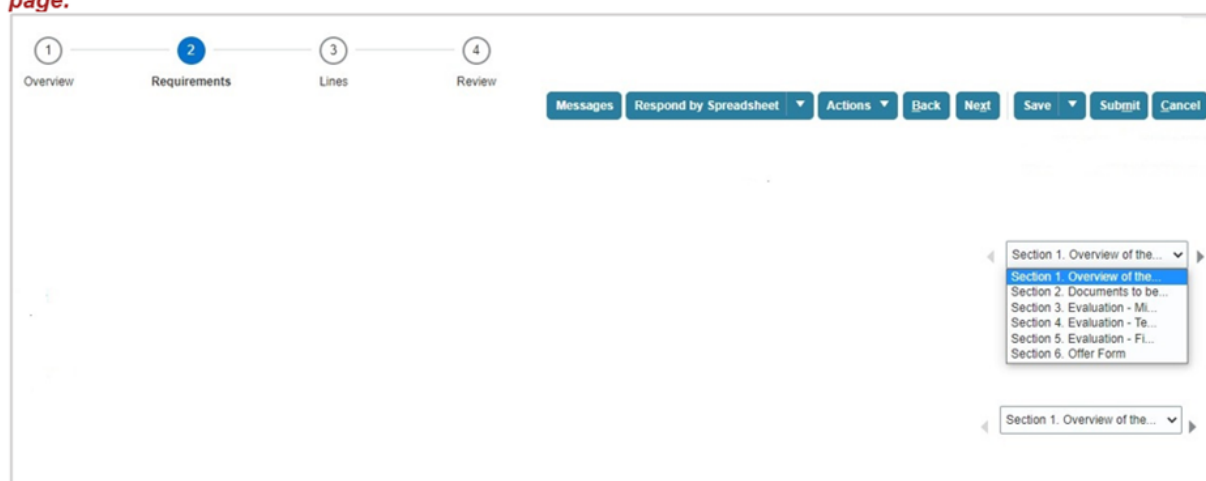

- Advance degree in environmental management, agricultural science or any other relevant field.
- At least 5 years of experience in agriculture sector.
- At least 3 years in working with National and Local Public Authorities
- Citizenship of the Republic of Moldova.

The screening shall be a desk review of application packages. Therefore, applicants are advised to highlight their compliance to notice requirements through including relevant information in the supporting documentation (CV, motivation letter, etc.)
