Section 5a: Scope of Works

1. Introduction and objectives

The **EU4Moldova: Focal Regions Programme** supports the strengthening of economic, territorial and social cohesion in the Republic of Moldova by facilitating sustainable and inclusive local social -economic growth and improving the standards of living of the citizens from the two focal regions: Ungheni and Cahul municipalities and the neighboring localities. The Programme will support the two regions through: making governance more efficient – improving quality of services and necessary infrastructure; incentivizing private sector – increasing investments, improving local economy and creating new jobs; encouraging participatory democracy – involving citizens in democratic governance processes and enhancing their capacities to claim their rights.

The Programme aims to achieve the following objectives:

1. To strengthen transparency, accountability of local public authorities and people's participation in local governance processes in the focal regions.

2. To improve citizens' access to quality public services and utilities in the pilot focal regions.

3. To create employment opportunities for men and women in the focal regions and improve the attractiveness of the pilot regions for investors and entrepreneurs.

4. To promote the smart specialization of the economy of the focal regions through the development of the clustering and value chain approach in key economic sectors.

As a result of Programme implementation, the institutional capacities of local public authorities will increase and get consolidated to support the fulfilment of the integrated and environmentally-mainstreamed local social-economic development strategy (e.g.: CSOs, private sector, etc.), and the planning and monitoring of the social-economic development strategy's implementation will become wider. Citizens will benefit from increased quality, availability and performance of local public services and utilities, including the ones meant for women. Favorable conditions will be created for attracting investments, creating working places and fostering local and social entrepreneurship. The economic performance will also increase in the focal regions as a result of clusters' and specialized zones' creation, according to the smart specialization of the economy.

The partners of the Programme are: EU Delegation in Moldova, UNICEF, Ministry of Agriculture, Regional Development and Environment, State Chancellery, Ministry of Finance, Ministry of Economy and Infrastructure, central and local public authorities from the focal regions Ungheni and Cahul, civil society groups and organizations, private sector and business associations, Public Services Agency, Electronic Governance Agency, Regional Development Agency Center and South, Congress of Local Authorities from Moldova, Organization for Development of Small and Medium Enterprises Sector, citizens.

Citizens and communities from Ungheni and Cahul regions, local public authorities and civil society organizations will be the final beneficiaries of this Programme.

2. Content of works

The EU4Moldova: Focal Regions Programme is looking for a company/consortium with proven experience in the area of civil and industrial construction to carry out reconstruction works related to **"Reconstruction and partial change of destination of the Buildings A, A' from cultural and recreational construction into the business development center in Crihana Veche village, Cahul district"**, located in Crihana Veche village,

Cahul district.

The content of works for "**Reconstruction and partial change of destination of the Buildings A, A' from cultural and recreational construction into the business development center in Crihana Veche village, Cahul district**" provide for reconstruction of buildings A and A" in the complex of building of the Gymnasium from the locality and subsequent development of these buildings into a Center for Business Development. The execution project provides for capital repairing of the roof, making and assembling the carpentry, thermalinsulating the facades, executing the riprap and the access ramps, finishing works for indoor premises, assembling works for electricity supply systems, building indoor and outdoor networks for water and sanitation supply, assembling works for natural gas supply system.

The Contractor shall ensure all the necessary elements for the successful fulfilment of the contract. As a rule, the Contractor should ensure: labor force, engineering, materials, equipment, support materials, transportation, machinery, working tools, labor and site protection measures, necessary lab samples and tests according to constructions norms and standards, launch into operation of engineering systems, as well as the trip costs, necessary for performing all the works under the respective contract. The teams which will carry out construction-assembling works should be led by a project supervisor certified in the area of civil and industrial constructions. The teams which will carry out specialized works (assembling electricity systems and installations, assembling signaling/warning systems, technical-sanitary works, etc.) should be led by a team leader with specialized training in the area. The works for assembling the natural gas supply system will be led by a project/site supervisor, certified in the area, and will be carried out in strict conformity with the requirements of the Law No. 803-XIV on Industrial Security of Dangerous Industrial Sites, as well as in line with the normative acts NRS 35-04-09:2002 "Security rules for gas-supply area", NCM G. 05.01-2006 "Gas distribution systems".

The contract will include the following activities:

- procurement and delivery to the construction site of materials and services, which are necessary for performing successfully the works;
- preparing the construction site for storing materials and executing works;
- performing reconstruction works, installation of technical-utility networks and subsequent territory development;
- launching into operation the performed construction works, and carrying out performance tests.

The physical and chemical characteristics of the construction materials suggested by contractors should meet the requirements from the tender specifications, as well as the below-mentioned guidelines, technical requirements and specifications. Construction materials delivered to the construction site should have national compliance certificates and/or European Certificate (CE), confirming quality indicators. The Contractor shall also ensure for all the materials to be used under the contract, to be coordinated in advance, before being used, with the representatives of the final Beneficiary and UNDP Moldova, accountable for daily supervision of the site and periodical monitoring of the works on the site.

Note for Bidders:

Whenever the technical specifications request a specific product, specific brand, name/model, the bidders may come up with suggestions to coordinate any other product, which would be equal from all points of view with the specified product, meeting all origin requirements, physical, functional, and performance parameters.

3. Construction site

The works announced in this tender shall be carried out in Crihana Veche village, Cahul district.

4. Organizational arrangements

The implementation of the project and the fulfilment of on-site works shall be monitored by the Engineer appointed by UNDP Moldova, who will systematically visit the construction site for monitoring. Additionally, the National Consultant for community infrastructure and the Engineer – Technical Responsible, authorized by the Local Public Authority, final Beneficiary of the project, shall ensure daily supervision of construction works and the quality of works' implementation as provided in the contact.

5. Expected results

The following *results* are expected from the Contractor:

Result 1: To finish all building-assembling works, as envisaged in the contract documents, within a deadline not exceeding **180** calendar days.

Result 2: To launch into final operation the respective site in: **12** months, since the date of finished works' reception at the site.

6. Main technical requirements and specifications

The construction and landscaping works shall be carried out in line with the provisions of the project documentation No. **024/2022** "Reconstruction and partial change of destination of the Buildings A, A' from cultural and recreational construction into the business development center in Crihana Veche village, Cahul district", developed in April 2022 by the design company "ARCA-CLASIC" SRL based on the Urbanism Certificate No. 1 of 02.02.2022. The respective project was developed, endorsed and verified as established in the normative documents in force in constructions area.

The works to be carried out are as follows:

Architectural solutions:

- Reconstruction of buildings A and A` of the complex of buildings under the Gymnasium in the locality to turn them into a Business Development Center.
- Demolishing the brick masonry walls and setting the open spaces, dismantling the plaster on the walls;
- Reconstructing the roof of "flat" type into a roof of "frame" type roof made of metal tile on wooden construction;
- Outdoor thermal insulation of building walls finishing the facades with plastering;
- Floors made of ceramic tiles;
- Internal finishing works made with dry plaster-based mixture, and plastering the walls with plasterboard;
- Suspended ceilings;
- Internal painting with vinyl copolymers-based paints in aqueous emulsion;
- Plywood made of ceramic tiles (on walls, columns, pillars and window sills);
- Manufacturing and assembling the carpentry made of PVC profiles;
- Transporting construction waste as a result of demolishing works, at a distance of about 5 km to the storage site set by the mayoralty of Crihana Veche village.

Laying the internal aqueduct and sewerage networks.

Electrical works for indoor electrical lighting / power electricity equipment. Installation of networks and outdoor installations of 0.4kV power supply. Laying of external water supply and sewerage networks. Laying of external and internal gas supply networks, installation of equipment.

7. Reception by the end of works

After finishing the construction works and sending all the execution documents, the procedure for launching the site into operation will be organized in line with the provisions set in the Regulation regarding the reception of constructions works and related installations, approved via the Government Decision No. 285 of 23.05.1996 (with subsequent changes and additions).

8. Warrantee period

The warrantee period for the performed works shall start on the date of site reception upon the end of the works and shall last for 36 months for works and materials.
