### A. Summary of Requirements

The given purchase is carried out within a single lot. All technical specifications and requirements described under Section 5, are set for the purchase of 16 full hybrid 4x4 (AWD) vehicles for the beneficiary institutions of each project described below:

- 2 hybrid vehicles for the National Legal Aid Council
- 14 hybrid vehicles for the Police General Inspectorate
- Additional equipment and color-graphic schemes and elements on 14 hybrid vehicles for Police (as per technical specifications and Annexes 1&2).

### B. Background

The overall objective of the **“Multidimensional response to emerging human security challenges in Moldova” Project** is to protect human security and enhance the resilience of the Republic of Moldova, in order to address the multifaceted and interconnected challenges of the current socio-economic, food and energy shocks.

Under Activity 3.2.1., the Project aims to enhance the mobility and response capacities of first-response police teams. Police service is at the frontline of the community security response, being usually the first service called in a security-related emergency. The capacity of police service to react promptly to these calls is crucial for saving lives, preventing and responding to crime or re-establishing public order.<sup>1</sup> Through this intervention the Project will support the prompt deployment of police services (including in remote areas) by providing at least 10 first response police teams in 5 districts with high number of settled refugees with fit-for-purpose police vehicles to enhance the mobility and rapid response capacities to community security calls or crisis situations. This support will be also instrumental in ensuring the safe passage of refugees from the border to host communities or transit the country on their route to other destinations. The intervention will embed, to the extent possible, environmental sustainability (emissions control, fuel consumption), hybrid vehicles being considered as a first option before combustion vehicles.

The **“Enhancing access to justice for living in dignity” Project’s** overall objective is to enhance the resilience of the rule of law system from the Republic of Moldova and strengthen its capacities to deliver effective remedies and provide access to public services. It is intended to address the multifaceted and interconnected challenges of the current policies through strengthening institutions, empowering vulnerable groups to access legal services and unlocking the potential of digital transformation in support of better access to justice.

To enhance rule of law system-wide capacities to address justice needs of vulnerable groups, including displaced people and host communities (System-wide Capacities), one of the project objectives is to support the creation and operationalization (regulations, SoP, staff capacity building, equipment, technologies and vehicles) of the mobile legal aid team service delivery model to diversify the range of services offered by the national legal aid system and reach out to those in need of legal assistance across the country.

### C. Scope and objectives of the contract

The scope of contract includes supply and delivery of 4x4(AWD) hybrid vehicles according to the requirements and specifications detailed in **Clause K. Technical Specifications for Goods** below. All parameters in the Technical Specifications indicate the minimum allowable range of functional requirements.
