A bid submitted with an adjustable price shall be treated as non-compliant and shall be rejected. However, if in accordance with Section 3: Data Sheet, prices quoted by the bidder shall be subject to adjustment during the performance of the Contract, a bid submitted with a fixed price quotation shall not be rejected, but the price adjustment shall be treated as zero. If indicated in Section 3: Data Sheet that bids are being invited for individual contracts (lots) and unless otherwise indicated in Section 3: Data Sheet, prices quoted shall correspond to 100 % of the items specified for each lot and to 100% of the quantities specified for each item of a lot. Bidders wishing to offer any price reduction (discount) for the award of more than one Lot shall specify the

During the bid validity period, the bidder shall maintain its original bid without any change, including the availability of the key personnel, the proposed rates and the total price.

In exceptional circumstances, prior to the expiration of the bid validity period, UNDP may request bidders to extend the period of validity of their bids. The request and the responses shall be made in writing, and shall be considered integral to the bid.

If the bidder agrees to extend the validity of its bid, it shall be done without any change to the original bid, but will be required to extend the validity of the bid security, if required, for the period of the extension, and in compliance with Article 19 (Bid security) in all respects.

The bidder has the right to refuse to extend the validity of its bid without forfeiting the bid security, if required, in which case, the bid shall not be further evaluated.

19. Bid Security

A bid security, if required by Section 3: Data Sheet, shall be provided in the amount and form indicated in the Section 3: Data Sheet. The bid security shall be valid for a minimum of thirty (30) days after the final date of validity of the bid.

The bid security shall be included along with the bid. If a bid security is required by the ITB but is not found in the bid, the offer shall be rejected.

If the bid security amount or its validity period is found to be less than is required by UNDP, UNDP shall reject the bid.

In the event an electronic submission is allowed in Section 3: Data Sheet, bidders shall include a copy of the bid security in their bid and the original of the bid security must be sent via courier or hand delivery as per the instructions in Section 3: Data Sheet.

Unsuccessful bidders' bid securities will be discharged/returned as promptly as possible but no later than thirty (30) days after the expiration of the period of bid validity prescribed by UNDP pursuant to Article 18 (Bid Validity Period).

The bid security may be forfeited by UNDP, and the bid rejected, in the event of any, or combination, of the following conditions:

- If the bidder withdraws its offer during the period of the bid validity specified in Section 3: Data Sheet, or;
- In the event the successful bidder fails:
 - o to sign the Contract after UNDP has issued an award; or
 - to furnish the Performance Security, insurances, or other documents that UNDP may require as a condition precedent to the effectivity of the contract that may be awarded to the bidder.

20. Joint Venture, Consortium or Association

If the bidder is a group of legal entities that will form or have formed a Joint Venture (JV), Consortium or Association for bid, each such legal entity will confirm in their joint bid that:

- they have designated one party to act as a lead entity, duly vested with authority to legally bind the members of the JV, Consortium or Association jointly and severally, and this will be evidenced by a duly notarised Agreement among the legal entities, which will be submitted along with the bid; and
- if they are awarded the contract, the contract shall be entered into by and between UNDP and the designated lead entity, who will be acting for and on behalf of all the member entities comprising the joint venture.

After the deadline for submission of bid, the lead entity identified to represent the JV, Consortium or Association shall not be altered without the prior written consent of UNDP.

If a JV, Consortium or Association's bid is the bid selected for award, UNDP will award the contract to the joint venture, in the name of its designated lead entity. The lead entity will sign the contract for and on behalf of all other member entities.

The lead entity and the member entities of the JV, Consortium or Association shall abide by the provisions of Article 21 (Only one Bid) herein in respect of submitting only one bid.

The description of the organization of the JV, Consortium or Association must clearly define the expected role of each of the entities in the joint venture in delivering the requirements of the ITB, both in the bid and the JV, Consortium or Association Agreement. All entities that comprise the JV, Consortium or Association shall be subject to the eligibility and qualification assessment by UNDP.

A JV, Consortium or Association in presenting its track record and experience should clearly differentiate between: Those that were undertaken together by the JV, Consortium or Association; and Those that were undertaken by the individual entities of the JV, Consortium or Association. Previous contracts completed by individual experts working privately but who are permanently or were temporarily associated with any of the member firms cannot be claimed as the experience of the JV, Consortium or Association or those of its members, but should only be claimed by the individual experts themselves in their presentation of their individual credentials. JV, Consortium or Associations are encouraged for high value, multi-sectoral requirements when the spectrum of expertise and resources required may not be available within one firm. 21. Only one bid The bidder (including the individual members of any Joint Venture) shall submit only one bid, either in its own name or as part of a Joint Venture. Bids submitted by two (2) or more bidders shall all be rejected if they are found to have any of the following: they have at least one controlling partner, director or shareholder in common; or any one of them receive or have received any direct or indirect subsidy from the other/s; they have the same legal representative for purposes of this ITB; or they have a relationship with each other, directly or through common third parties, that puts them in a position to have access to information about, or influence on the bid of another bidder regarding this ITB process; they are subcontractors to each other's bid, or a subcontractor to one bid also submits another bid under its name as lead bidder; or some key personnel proposed to be in the team of one bidder participates in more than one bid received for this ITB process. This condition relating to the personnel, does not apply to subcontractors being included in more than one bid. 22. Alternative bids Unless otherwise specified in Section 3: Data Sheet, alternative bids shall not be considered. If submission of alternative bid is allowed in Section 3: Data Sheet, a bidder may submit an alternative bid, but only if it also submits a bid conforming to the ITB requirements. Where the conditions for its acceptance are met, or justifications are clearly established, UNDP reserves the right to award a contract based on an alternative bid. If multiple/alternative bids are being submitted, they must be clearly marked as "Main Bid" and "Alternative Bid". If no indication is provided as to which bid is the main bid and which is/are the alternative bid(s), then all bids will be rejected. 23. Pre-bid When appropriate, a pre-bid conference will be conducted at the date, time and location and conference according to any instructions specified in Section 3: Data Sheet. If it is stated in Section 3: Data Sheet that the pre-bid conference is mandatory, a bidder which does not attend the pre-bid conference shall become ineligible to submit a bid under this ITB. If it is stated in Section 3: Data Sheet that the pre-bid conference is not mandatory, non-attendance shall not result in disqualification of an interested bidder. UNDP will not issue any formal answers to questions from bidders regarding the ITB or bid process during the pre-bid conference. All questions shall be submitted in accordance with Article 41 (Clarification of Bids). The pre-bid conference shall be conducted for the purpose of providing background information only. Without limiting Article 26 (Bidders Responsibility) bidders shall not rely upon any information, statement or representation made at the pre-bid conference unless that information, statement or representation is confirmed by UNDP in writing. Minutes of the pre-bid conference will be disseminated as specified in Section 3: Data Sheet. No verbal statement made during the conference shall modify the terms and conditions of the ITB, unless specifically incorporated in the minutes of the bidder's conference or issued/posted as an amendment to ITB.

When appropriate, a site inspection will be conducted at the date, time and location and according

to any instructions specified in Section 3: Data Sheet.

24. Site inspection

If it is stated in Section 3: Data Sheet that the site inspection is mandatory, a bidder which does not attend the site inspection shall become ineligible to submit a bid under this ITB.

If it is stated in Section 3: Data Sheet that the site inspection is not mandatory, non-attendance, shall not result in disqualification of an interested bidder.

Bidders participating in a site inspection shall be responsible for making and obtaining any visa arrangements that may be required for the bidders to participate in a site inspection.

Prior to attending a site inspection, bidders shall execute an indemnity and a waiver releasing UNDP in respect of any liability that may arise from:

- (i) loss of or damage to any real or personal property;
- (ii) personal injury, disease or illness to, or death of, any person;
- (iii) financial loss or expense, arising out of the carrying out of that site inspection; and
- (iv) transportation by UNDP to the site (if provided) as a result of any accidents or malicious acts by third parties.

will not issue any formal answers to questions from bidders regarding the ITB or bid process during a site inspection. All questions shall be submitted in accordance with Article 8 (Clarification of solicitation documents).

A site inspection will be conducted for the purpose of providing background information only. Without limiting Article 26 (Bidders Responsibility), bidders shall not rely upon any information, statement or representation made at a site inspection unless that information, statement or representation is confirmed by UNDP in writing.

25. Errors or omissions

Bidders shall immediately notify UNDP in writing of any ambiguities, errors, omissions, discrepancies, inconsistencies or other faults in any part of the ITB, with full details of those ambiguities, errors, omissions, discrepancies, inconsistencies or other faults.

Bidders shall not benefit from such ambiguities, errors, omissions, discrepancies, inconsistencies or other faults.

26. Bidders responsibility to inform themselves

Bidders shall be responsible for informing themselves in preparing their bid. In this regard, bidders shall ensure that they:

- examine and fully inform themselves in relation to all aspects of the ITB, including the Contract and all other documents included or referred to in this ITB;
- review the ITB to ensure that they have a complete copy of all documents;
- obtain and examine all other information relevant to the project and the scope of the requirements available on reasonable enquiry;
- verify all relevant representations, statements and information, including those contained or referred to in the ITB or made orally during any clarification meeting or site Inspection or any discussion with UNDP, its employees or agents;
- attend any Pre-bid conference or site inspection if it is mandatory under this ITB;
- fully inform and satisfy themselves as to requirements of any relevant authorities and laws that apply, or may in the future apply, to the supply of the goods, works and/or services; and
- form their own assessment of the nature and extent of the goods, works and /or services required as included in Section 5: Schedule of Requirements and properly account for all requirements in their bid.

Bidders acknowledge that UNDP, its directors, employees and agents make no representations or warranties (express or implied) as to the accuracy, currency or completeness of this ITB or any other information provided to the bidders.

27. No material change(s) in circumstances

The bidder shall inform UNDP of any change(s) of circumstances arising during the ITB process, including but not limited to:

- a change affecting any declaration, accreditation, license or approval;
- major re-organisational changes, company re-structuring, a take-over, buy-out or similar event(s) affecting the operation and/or financing of the bidder or its major sub-contractors;
- a change to any information on which UNDP may rely in assessing bids.

Instruction for The bidder shall submit a duly signed and complete bid comprising the documents and forms in bid submission accordance with requirements in Section 3: Data Sheet. The bid shall be signed by the bidder or person(s) duly authorized to commit the bidder. 1. SCOPE OF WORKS

A. Summary of Requirements

Requirements are comprised of the following Lots:

- Lot 1: Construction works of 10 safe spaces for play, recreation and sports in Ungheni
- Lot 2: Construction works of a multi-functional sports field in Cahul

B. Introduction and objectives

Moldova is facing a compound crisis of energy and food security, curtailed economic growth, growing inflation, limited institutional capacities and divisions in society, aggravated by the continuing socio-economic impact of the COVID-19 pandemic and the war in Ukraine.

The influx of refugees presents an additional challenge that requires sustained attention and support from the international community. Without urgent intervention, the deepening socio-economic, energy, food and human security crises has the potential to derail the trajectory of development, and drastically increase human suffering of people in Moldova, whether Ukrainian refugees, third country nationals, or Moldovan citizens (including those from minority ethnic groups). There are risks of massive outmigration and brain drain, as an immediate impact of the worsening of the socio-economic situation, depleting the country of its major asset: human capital.

With this project, UNDP ensures that immediate humanitarian assistance is complemented by development efforts across three core insecurities (energy, food, community) to protect and maintain vital systems, structures, and a capacity to support Moldova's resilience.

The overall objective of the intervention is to protect human security and enhance the resilience of the Republic of Moldova, to address the multifaceted and interconnected challenges of the current socio-economic, food and energy shocks.

The three specific objectives are:

- To enhance people's energy security through access to affordable energy that supports livelihoods and energy-efficient production;
- To enhance food security by supporting the government to implement its Food Security Strategy, thereby strengthening the capacities of agricultural producers affected by the compound crises;
- To enhance community security by strengthening the capacities of the police service and community actors to deliver on the principles of social cohesion and peaceful coexistence.

C. Content of works

UNDP seeks company or consortium of companies that will demonstrate experience in the construction/installation of playgrounds and sports grounds, for the execution of works on the object:

- Lot 1: Construction works of a safe space for play, recreation and sports in Ungheni. 10 playgrounds and fitness grounds in Ungheni municipality.
- Lot 2: Construction works of a multi-functional sports field in Cahul. The sport field will be constructed in the yard of the theoretical high school "Dimitrie Cantemir" in the municipality of Cahul, in order to promote a healthy way of life among young people and refugees from Ukraine.

Under both LOTs it is envisaged that the works will include the following activities:

- procurement and delivery to the site of the materials and services required to successfully execute the works;
- site preparation for storing materials, execution of works;
- execution of construction and land development works;
- commissioning of the construction works carried out.

All these activities shall be carried out in accordance with the provisions of the Bills of Quantities (BoQ).

The physical and chemical properties of the construction materials proposed by the contractors shall be in accordance with the requirements of the Bills of Quantities and the specifications in the working drawings and with the technical guidelines, requirements and specifications as required below. The construction materials delivered to the site must be accompanied by national certificates of conformity and/or European Certificates (EC) attesting the quality standards. The contractor should also ensure that all materials to be used under the contract are coordinated, prior the execution, with the representatives of the final Beneficiary and UNDP Moldova who are in charge of the day-to-day supervision of the site and regular monitoring of the on-site works.

The Company/Consortium taking part in the tendering procedure shall provide everything necessary for the successful performance of the contract. The Company/Consortium shall ensure the supervision of the works on site-by-site supervisors certified according to the classification (Government Decision No 329 of 23 April 2009, amended by Government Decision No 207 of 30 March 2022) for general and specialized works.

The Company/Consortium shall perform the works using the skilled labor, materials, mechanisms, machinery and equipment necessary to carry out the works specified in the Specifications. The Company/Consortium shall comply with labour and site protection measures, carry out the necessary laboratory sampling and testing in compliance with the construction rules and standards, ensure the commissioning of engineering systems.

Note for bidders:

Whenever the technical specifications require a specific product, specific brand/model, the bidders may come up with proposals for an alternative product equivalent in all aspects with the specified product and meeting the requirements regarding physical, functional and performance parameters.

LOT 1: CONSTRUCTION WORKS OF A SAFE SPACE FOR PLAY, RECREATION AND SPORTS IN UNGHENI.

The construction of the object under LOT 1 provides for the following types of works:

- plotting the axes of the playgrounds and earthworks;
- installing the perimetral borders;
- installation of play elements and fitness elements;
- landscaping the playground and fitness area with river gravel;
- installing park benches and trash cans;
- landscaping around the playground and the fitness area;

All these types of works and activities will contribute to the creation of a safe space for children, youth and adults from Ungheni and refugees from Ukraine, temporarily settled in Ungheni, for recreational and sports activities, for their better interaction and social integration, as well as for improving the quality of life of the community by promoting a healthy and active lifestyle.

EXPECTED OUTPUTS (LOT 1)

In accordance with the sequence of the works the following results are to be obtained:

- 1. The development of 10 surfaces with dimensions of 10m x 20m, with the installation of the perimeter border and the filling of the surface with river stone;
- 2. Installation of ninety play elements, for different age categories of children;
- 3. Installation of forty fitness elements, for training various categories of muscles;
- 4. Installation of 80 benches and 60 trash cans, located around the perimeter of the playgrounds;
- 5. Installing an information board about the rules for using the fitness elements and the play elements.

The volume of works to be carried out are indicated in the Bill of Quantities (List of work volumes/BoQ).

The following outcomes are expected to be provided by the Contractor:

Outcome 1: Completion of all construction works set out in the contract documents, within no more than 90 calendar days. Once the construction works are completed and the execution documents are submitted, the completed on-site works shall be commissioned in compliance with the provisions of the Regulation on the acceptance of construction works and related installations, approved by the Republic of Moldova Government Decision No 285 of 23.05.1996.

Outcome 2: Final commissioning of the facility after the expiry of the 1-year warranty period from the date of commissioning of the facility on completion of the works.

The construction site is located in Ungheni municipality at the following addresses:

- 5) The space in the area of the fitness field behind the "Vasile Alecsandri" Theoretical High School
- 6) The space in the Ungheni Deal land area
- 7) The space located at the intersection of Nuferilor and Dănuţeni streets
- 8) The court located at Caragiale 3 and Caragiale 5 streets
- 9) The space in the square in the Dănuțeni neighborhood
- 10) The court located at Romană 66, Romană 68, Decebal 12, Decebal 16 streets

The construction waste, resulting from excavation, will be transported about 5 km to a disposal site established by the City Hall of Ungheni.

The reporting on the work progress shall take place on a monthly basis through the submission of a Minutes of Acceptance of the works carried out during the preceding 30 calendar days. The minutes shall be signed by the Company Manager/Contractor and the certified Site Manager with the application of the stamps and forwarded for verification to the certified Technical Manager, the Beneficiary's permanent representative on site. Subsequently, the Minutes of Acceptance of the works carried out, signed by the certified Technical Manager, will be countersigned by the National Consultant for Community Infrastructure and submitted for verification and approval to the office of the EU4Moldova: Focal Regions Programme.

DURATION OF THE WORK (LOT 1)

The Successful Bidder will sign with UNDP Moldova the Contract for the works. The Contract shall be valid for a period of 15 months from the date on which the Successful Bidder, hereinafter referred to as the Contractor, is granted access to the site and receives notification from the UNDP Engineer to commence the works, ending on the date of signing of the Minutes of Final Acceptance of Works. The 15-month period includes 3 months for completion of the works and 12 months of defects liability period.

The projected target start date is **04 September 2023**. The projected target date for completion is **30 November 2023**. The Final Acceptance of Works is expected to take place on **30 November 2024**.

The Bidders, as part of the tender documents, shall submit a detailed Works Execution Schedule including the estimated start and completion dates for each section of the tender estimate in accordance with the technological procedures. The Successful Bidder shall, within 5 calendar days from the date of signing of the contract, submit for approval the updated Schedule of Works.

DUTY STATION (LOT 1)

The construction site will be located in ten locations in Ungheni municipality. The compound/warehouse for the storage of construction materials, the parking of machinery and equipment and the campus for workers and engineering staff will be located in the construction area of the object. The Successful Bidder shall prepare an execution project for the organisation of the construction site, including measures for the protection of the environment, measures for the safe organisation of road traffic, measures for occupational safety during the execution of the works.

The Works Manager/certified Site Manager and the foremen of the specialised works teams are to be present every 2 weeks at the working group meeting. The meetings will be held on Fridays, from 10:00 a.m. to 12:00 p.m. in the premises of the Ungheni City Hall. The working group shall be established by order of the Mayor of Ungheni City Hall.

The construction of the object under LOT 2 provides for the following types of works:
