

Deadline for the submission of offers for provision of body camera solution has been postponed until March 12, 2024, by cob.

Q&A to RFQ

1. La pozitia 1 Body camera - Integrated RFID tag. Diferiti producatori folosesc cititorul RFID in doua moduri - integrat in Camera sau amplasat in locul preluarii/locatiei si/sau alaturi de statiile de andocare. Astfel solicitam operarea modificarilor ce ar permite amplasarea cititoarelor atat integrat in camera de corp, atat si separat la locul andocarii. Aceste modificari nu ating niciunul din scopurile lucrativitate a sistemului.

RĂSPUNS LA CLARIFICARE: Integrated RFID tag - se folosește pentru autentificarea ofițerului de poliție cu ajutorul legitimației. Ulterior sistemul aleatoriu alege bodycamera după prezentarea legitimației și care selectează camera încărcată la 100%.

2. La pozitia 1 Body camera - audio bitrate 128 kbps - unele modele nu au nevoie de indicele 128 intrucat este suficient si 64 kbps pentru a transmite sunetul fara careva probleme de calitate sau integritate.

RĂSPUNS LA CLARIFICARE: Da, se accepta.

3. La pozitia 1 Body camera - Sticker. Va rugam respectuos sa ne explicati despre ce fel de sticker merge vorba. Nu este clara utilitatea si necesitatea acestei pozitii. Ce functii v-a indeplini?

RĂSPUNS LA CLARIFICARE: Stickerul urmează a fi alipit pe camera portabilă și este folosită ca material informativ și atenționează că se face filmarea.

4. La pozitia 2 charging station - se solicita conectivitate prin USB. Solicitam modificarea acestei solicitari deoarece primordiala ar fi insasi conexiunea ci nu tipul acesteia - USB/Network s.a.

RĂSPUNS LA CLARIFICARE: Da, se acceptă.

5. La pozitia 1 Body Camera - Triggers the camera to start recording when others are within a configurable radius - Rugam sa explicati ce ar trebui sa serveasca trigger? Totodata studiind datasheet al modelului Motorola indicat ca exemplu, nu am gasit asa tip de functie.

RĂSPUNS LA CLARIFICARE: Triggers the camera to start recording when others are within a configurable radius – funcția data permite conectarea automata a camerelor de corp aflate în preajma în momentul conectării inițiatorului și permite vizualizarea cazului din diferite unghiuri.

Per total solicitam si eliminarea denumirelor exacte a licentelor si a protocoalelor folosite de Motorola deoarece ofertind o solutie de la alt producator acestea devin irelevante, neafectind astfel partea lucrativa a solutiei ce urmeaza a fi propusa.

Nu se acceptă din considerderul că Inspectoratul General al Poliției urmărește scopul de a-și extinde soluția bodycam pe platformă deja creată.

Pentru formularea unei oferte efective si a unei solutii exhaustive solicitam respectuos specificarea exacta a cantitatilor de camere per locatie, pentru a putea oferta cantitatea necesara de statii de andocare si statii de incarcare.

RĂSPUNS LA CLARIFICARE: Conform caietului de sarcini cantitatea de camere de corp poate varia de la locație la locație in dependenta de necesitatea beneficiarului.

1. At position 1 Body camera - Integrated RFID tag. Different manufacturers use the RFID reader in two ways - integrated into the Camera or placed at the pick-up/location location and/or next to docking stations. Thus, we request the operation of changes that would allow the placement of readers both integrated in the body chamber and separately at the docking site. These changes do not affect the lucrative part of the system in any way.

ANSWER TO CLARIFICATION: Integrated RFID tag - is used to authenticate the police officer with the help of the badge. Subsequently, the random system chooses the bodycamera after presenting the badge and which selects the room charged at 100%.

2. At position 1 Body camera - audio bitrate 128 kbps - some models do not need index 128 as it is enough 64 kbps to transmit sound without any problems of quality or integrity.

REPLY TO CLARIFICATION: Yes, it is accepted.

3. At position 1 Body camera - Sticker. We kindly ask you to explain what kind of sticker it is. It is not clear the usefulness and necessity of this position. What functions will it perform?

ANSWER TO CLARIFICATION: The sticker is to be attached to the portable camera and is used as information material and warns that filming is done.

4. At position 2 charging station - USB connectivity is required. We request the modification of this request because the connection itself would be paramount, not this type - USB/Network etc.

REPLY TO CLARIFICATION: Yes, it is accepted.

5. At position 1 Body Camera - Triggers the camera to start recording when others are within a configurable radius - Please explain what the trigger should serve? At the same time, studying the datasheet of the Motorola model indicated as an example, I did not find such a function.

ANSWER TO CLARIFICATION: Triggers the camera to start recording when others are within a configurable radius – the data function allows automatic connection of body cameras nearby when connecting the initiator and allows viewing the case from different angles.

Overall, we also request the removal of the exact names of licenses and protocols used by Motorola because by offering a solution from another manufacturer they become irrelevant, thus not affecting the lucrative part of the solution to be proposed.

It is not accepted because the General Police Inspectorate is pursuing the goal of expanding its bodycam solution on the platform already created.

In order to formulate an effective offer and an exhaustive solution, we respectfully request the exact specification of the quantities of rooms per location, in order to be able to offer the necessary quantity of docking stations and charging stations.

ANSWER TO CLARIFICATION: According to the specification, the quantity of body cameras may vary from location to location depending on the beneficiary's need.
