UNDP is hereby amending the following:

**1. Eligibility and Qualification Criteria** is hereby amended as follows:

<b>Qualification Criteria</b>	<b>Documents to establish compliance</b>
History of non-performing contracts <sup>1</sup> : Non-performance of a contract did not occur as a result of contractor default within the last 3 years.	Form F: Eligibility and Qualification
Litigation History: No consistent history of court/arbitral award decisions against the bidder for the last 3 years.	Form F: Eligibility and Qualification
<b>Previous Experience:</b>	
Minimum five (5) years of relevant experience in <del>the manufacturing and delivery</del> <b>supply</b> of furniture  (For JV/Consortium/Association, the <b>Lead Company</b> should meet requirement).	Form F: Eligibility and Qualification
<b>Bidders applying for single LOTS should demonstrate the following experience:</b>  Minimum two (2) contracts in <del>the manufacturing and delivery</del> <b>supply</b> of furniture specific for each LOT, implemented within the last five (5) years.  The contracts should not be less than the following amounts:	Form F: Eligibility and Qualification

<sup>1</sup> Non-performance, as decided by UNDP, shall include all contracts where (a) non-performance was not challenged by the contractor, including through referral to the dispute resolution mechanism under the respective contract, and (b) contracts that were so challenged but fully settled against the contractor. Non-performance shall not include contracts where Employers decision was overruled by the dispute resolution mechanism. Non-performance must be based on all information on fully settled disputes or litigation, i.e. dispute or litigation that has been resolved in accordance with the dispute resolution mechanism under the respective contract and where all appeal instances available to the Bidder have been exhausted.

<b>Financial Standing:</b>	
<p><b>Liquidity:</b> the ratio Average current assets/Current liabilities over the last 3 years must be equal or greater than 1.</p> <p><u>If QR is less than 1:</u> UNDP shall verify financial capacity of the bidder and had the authority to seek references from concerned parties &amp; banks on the bidder' financial standing. UNDP had the right to reject any bid if submitted by a contractor whom investigation leads to a result that he is not financially capable and/or had serious financial problems.</p> <p><i>(For JV/Consortium/Association, <b>all Parties cumulatively</b> should meet requirement).</i></p>	<p>Copy of audited financial statements for the last three years.</p> <p>Form F: Eligibility and Qualification</p>
