GENERAL	
1. Scope	<p>Proposers are invited to submit a proposal for the services specified in Section 5: Terms of Reference in accordance with this Request for Proposal (RFP). Section 3: Data Sheet includes a summary of the proposal's scope.</p> <p>Proposers shall adhere to all the requirements of this RFP, including any amendment made in writing by UNDP. This RFP is conducted following UNDP's Policies and Procedures, which can be accessed at UNDP Programme and Operations Policies and Procedures/Procurement.</p> <p>It is desired that the Bidder registers at the United Nations Global Marketplace (UNGM) website (www.ungm.org) as part of the bid. The Bidder may submit a bid even if not registered with the UNGM. However, if the Bidder is selected for contract award, the Bidder must register on the UNGM before the contract signature.</p>
2. Interpretation of the RFP	<p>Any proposal submitted will be regarded as an offer by the proposer and does not constitute or imply UNDP's acceptance of the proposal. UNDP is not obligated to award a contract to any proposer as a result of this RFP.</p>
3. Supplier Code of Conduct, Fraud, Corruption, Gifts and Hospitality	<p>All proposers must read the United Nations Supplier Code of Conduct and acknowledge that it provides the minimum standards expected of suppliers to the UN. 5. Proprietary information	<p>The RFP documents and any Terms of Reference or information issued or furnished by UNDP are issued solely for the purpose of enabling a proposal to be completed and may not be used for any other purpose. The RFP documents and any additional information provided to proposers shall remain the property of UNDP. All documents which may form part of the proposal will become the property of UNDP, who will not be required to return them to your firm.</p>
6. Publicity	<p>During the RFP process, a proposer is not permitted to create any publicity in connection with the RFP.</p>

7. Clarification of solicitation documents	<p>Proposers may request clarifications on any of the RFP documents no later than the date indicated in Section 3: Data Sheet. Any request for clarification must be sent in writing in the manner indicated in Section 3: Data Sheet. Explanations or interpretations provided by personnel other than the named contact person will not be considered binding or official.</p> <p>UNDP will provide the responses to clarifications through the method specified in</p>

	<p>Section 3: Data Sheet.</p> <p>UNDP shall endeavour to provide responses to clarifications in an expeditious manner, but any delay in such response shall not cause an obligation on the part of UNDP to extend the submission date of the proposals, unless UNDP deems that such an extension is justified and necessary.</p>
8. Amendment of solicitation documents	<p>At any time prior to the deadline for proposal submission, UNDP may for any reason, such as in response to a clarification requested by a proposer, modify the RFP in the form of an amendment to the RFP. Amendments will be made available to all prospective proposers.</p> <p>If the amendment is substantial, UNDP may extend the deadline for submission of proposals to give the proposers reasonable time to incorporate the amendment into their proposal.</p>

9. Cost of preparation of proposal	<p>The proposer shall bear all costs related to the preparation and/or submission of the proposal, regardless of whether its proposal is selected or not. UNDP shall not be responsible or liable for those costs, regardless of the conduct or outcome of the procurement process.</p>
10. Language	<p>The proposal, as well as any and all related correspondence exchanged by the proposer and UNDP, shall be written in the language(s) specified in Section 3: Data Sheet.</p>
11. Documents establishing eligibility and qualifications of the proposer	<p>The proposer shall furnish documentary evidence of its status as an eligible and qualified vendor, using the forms provided in Section 7 and providing the documents required in those forms. To award a contract to a proposer, its qualifications must be documented to UNDP's satisfaction.</p>
11.a Documents comprising the proposal	<p>The proposal bid shall comprise of the following documents and related forms which details are provided in Section 3: Data Sheet:</p> <ul style="list-style-type: none"> ▪ Documents Establishing the Eligibility and Qualifications of the Bidder; ▪ Technical Proposal; ▪ Financial Proposal; ▪ Proposal Security, if required by DS; ▪ Any attachments and/or appendices to the Proposal.
12. Technical proposal format and content	<p>The proposer is required to submit a technical proposal using the forms provided in Section 7 and taking into consideration the requirements in the RFP.</p> <p>The technical proposal shall not include any price or financial information. A technical proposal containing material financial information may be declared non-responsive.</p>
13. Financial proposal	<p>The financial proposal shall be prepared using the form provided in Section 7 and taking into consideration the requirements in the RFP. It shall list all major cost components associated with the services, and the detailed breakdown of such costs.</p> <p>Any output and activities described in the technical proposal but not priced in the financial proposal, shall be assumed to be included in the prices of other activities or items as well as in the final total price.</p> <p>Prices and other financial information must not be disclosed in any other place except in the financial proposal.</p>
14. Currencies	<p>All prices shall be quoted in the currency or currencies indicated in Section 3: Data Sheet. Where proposals are quoted in different currencies, for the purposes of comparison of all proposals:</p> <ul style="list-style-type: none"> • UNDP will convert the currency quoted in the proposal into the UNDP preferred currency, in accordance with the UN Operational Rate of Exchange.

	<ul style="list-style-type: none"> In the event that UNDP selects a proposal for an award that is quoted in a currency different from the preferred currency in Section 3: Data Sheet, UNDP shall reserve the right to award the contract in the currency of UNDP's preference, using the conversion method specified above.
15. Duties and taxes	Article II, Section 7, of the Convention on the Privileges and Immunities provides, inter alia, that the United Nations, including UNDP as a subsidiary organ, is exempt from all direct taxes, except charges for public utility services, and is exempt from customs restrictions, duties, and charges of a similar nature in respect of articles imported or exported for its official use. 16. Proposal validity period	<p>Proposals shall remain valid for the period specified in Section 3: Data Sheet, commencing on the deadline for submission of proposals. A proposal valid for a shorter period may be rejected by UNDP and rendered non-responsive.</p> <p>During the proposal validity period, the proposer shall maintain its original proposal without any change, including the availability of the key personnel, the proposed rates and the total price.</p> <p>In exceptional circumstances, before the expiration of the proposal validity period, UNDP may request proposers to extend the validity period of their proposals. The request and the responses shall be made in writing and shall be considered integral to the proposal.</p> <p>If the proposer agrees to extend the validity of its proposal, it shall be done without any change to the original proposal but will be required to extend the validity of the proposal security, if required, for the period of the extension and in compliance with Article 17 (Proposal security) in all respects.</p> <p>If necessary, the proposer has the right to refuse to extend the validity of its proposal without forfeiting the proposal security, in which case the proposal shall not be further evaluated.</p>
17. Proposal security	<p>If Section 3: Data Sheet requires a proposal security in the amount and form indicated in Section 3: Data Sheet. The proposal security shall be valid for a minimum of thirty (30) days after the final date of validity of the proposal.</p> <p>The proposal security shall be included along with the proposal. If the RFP requires a proposal security but is not found in the proposal, the offer shall be rejected.</p> <p>If the proposal security amount or validity period is found to be less than what UNDP requires, UNDP will reject the proposal.</p> <p>In the event an electronic submission is allowed in Section 3: Data Sheet, proposers shall include a copy of the proposal security in their proposal, and the original must be sent via courier or hand delivery as per the instructions in Section 3: Data Sheet.</p> <p>Unsuccessful proposers' proposal securities will be discharged/returned as promptly as possible but no later than thirty (30) days after the expiration of the period of proposal validity prescribed by UNDP pursuant to Article 16 (Proposal Validity Period).</p> <p>The Proposal security may be forfeited by UNDP, and the proposal rejected, in the event of any, or combination, of the following conditions:</p> <ul style="list-style-type: none"> If the proposer withdraws its offer during the period of the proposal validity specified in Section 3: Data Sheet, or; In the event the successful Proposer fails: <ul style="list-style-type: none"> to sign the contract after UNDP has issued an award; or to furnish the performance security, insurances, or other documents that UNDP may require as a condition precedent to the effectivity of the contract that may be awarded to the proposer.

18. Joint Venture, Consortium or Association	<p>If the proposer is a group of legal entities that will form or have formed a Joint Venture (JV), Consortium or Association for the proposal, each such legal entity will confirm in their joint proposal that:</p> <ul style="list-style-type: none"> • they have designated one party to act as a lead entity, duly vested with the authority to legally bind the members of the JV, Consortium or Association jointly and severally, and this will be evidenced by a duly notarized agreement among the legal entities, which will be submitted along with the proposal; and • if they are awarded the contract, it shall be entered into by and between UNDP and the designated lead entity, which will act for and on behalf of all the joint venture member entities. <p>After the proposal submission deadline, the lead entity identified to represent the JV, Consortium, or Association may not be altered without the prior written consent of UNDP.</p> <p>If a JV, Consortium, or Association's proposal is selected for award, UNDP will award the contract to the joint venture in the name of its designated lead entity. The lead entity will sign the contract for and on behalf of all other member entities.</p> <p>The lead entity and the member entities of the JV, Consortium, or Association shall abide by the provisions of Article 19 (Only one Proposal) herein regarding submitting only one proposal.</p> <p>The description of the organization of the JV, Consortium, or Association must clearly define the expected role of each entity in the joint venture in delivering the requirements of the RFP, both in the proposal and the JV, Consortium, or Association Agreement. All entities that comprise the JV, Consortium, or Association shall be subject to UNDP's eligibility and qualification assessment.</p> <p>A JV, Consortium or Association, in presenting its track record and experience, should clearly differentiate between:</p> <ul style="list-style-type: none"> • Those that were undertaken together by the JV, Consortium or Association; and • Those that were undertaken by the individual entities of the JV, Consortium or Association. <p>Previous contracts completed by individual experts working privately but who are permanently or temporarily associated with any of the member firms cannot be claimed as the experience of the JV, Consortium, Association, or its members; it should only be claimed by the individual experts themselves in their presentation of their individual credentials.</p> <p>JVs, Consortia, or Associations are encouraged for high-value, multi-sectoral requirements when the spectrum of expertise and resources required may not be available within one firm.</p>
19. Only one proposal	<p>The proposer (including the individual members of any Joint Venture) shall submit only one proposal in its own name or as part of a Joint Venture.</p> <p>Proposals submitted by two (2) or more proposers shall all be rejected if they are found to have any of the following:</p> <ul style="list-style-type: none"> • they have at least one controlling partner, director or shareholder in common; or • any one of them receive or have received any direct or indirect subsidy from the other/s; or • they have the same legal representative for purposes of this RFP; or • they have a relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the proposal of another proposer regarding this RFP process;

	<ul style="list-style-type: none"> • they are subcontractors to each other's proposal, or a subcontractor to one proposal also submits another proposal under its name as lead proposer; or some key personnel proposed to be in the team of one proposer participates in more than one proposal received for this RFP process. This condition relating to • the personnel, does not apply to subcontractors being included in more than one proposal.
20. Alternative proposals	<p>Unless otherwise specified in Section 3: Data Sheet, alternative proposals shall not be considered. If submission of alternative proposals is allowed in Section 3: Data Sheet, a proposer may submit an alternative proposal, but only if it also submits a proposal conforming to the RFP requirements. Where the conditions for its acceptance are met, or justifications are clearly established, UNDP reserves the right to award a contract based on an alternative proposal.</p> <p>If multiple/alternative proposals are being submitted, proposer must create an alternate response directly in the system and upload all attachments relevant to the alternate proposal separately together with the alternate response.</p>
21. Pre-proposal conference	<p>When appropriate, a pre-proposal conference will be conducted at the date, time and location and according to any instructions specified in Section 3: Data Sheet.</p> <p>If it is stated in Section 3: Data Sheet that the pre-proposal conference is mandatory, a Proposer which does not attend the pre-proposal conference shall become ineligible to submit a proposal under this RFP.</p> <p>If it is stated in Section 3: Data Sheet that the pre-proposal conference is not mandatory, non-attendance shall not result in disqualification of an interested proposer.</p> <p>UNDP will not issue any formal answers to questions from proposers regarding the RFP or proposal process during the pre-proposal conference. All questions shall be submitted in accordance with Article 38 (Clarification of Proposals).</p> <p>The pre-proposal conference shall be conducted for the purpose of providing background information only. Without limiting Article 24 (Proposers' responsibility) proposers shall not rely upon any information, statement or representation made at the pre-proposal conference unless that information, statement or representation is confirmed by UNDP in writing.</p> <p>Minutes of the pre-proposal conference will be disseminated as specified in Section 3: Data Sheet. No verbal statement made during the conference shall modify the terms and conditions of the RFP, unless specifically incorporated in the minutes of the proposer's conference or issued/posted as an amendment to RFP.</p>
22. Site inspection	<p>When appropriate, a site inspection will be conducted at the date, time and location and according to any instructions specified in Section 3: Data Sheet.</p> <p>If it is stated in Section 3: Data Sheet that the site inspection is mandatory, a proposer who does not attend the site inspection shall become ineligible to submit a proposal under this RFP.</p> <p>If it is stated in Section 3: Data Sheet that the site inspection is not mandatory, non-attendance, shall not result in disqualification of an interested proposer.</p> <p>Proposers participating in a site inspection shall be responsible for making and obtaining any visa arrangements that may be required for the proposers to participate in a site inspection.</p> <p>Prior to attending a site inspection, proposers shall execute an indemnity and a waiver releasing UNDP in respect of any liability that may arise from:</p> <ul style="list-style-type: none"> (i) loss of or damage to any real or personal property; (ii) personal injury, disease or illness to, or death of, any person;

Errors or omissions	<p>Proposers shall immediately notify UNDP in writing of any ambiguities, errors, omissions, discrepancies, inconsistencies, or other faults in any part of the RFP, with full details of those ambiguities, errors, omissions, discrepancies, inconsistencies, or other faults.</p> <p>Proposers shall not benefit from such ambiguities, errors, omissions, discrepancies, inconsistencies, or other faults.</p>
24. Proposers' responsibility to inform themselves	<p>Proposers shall be responsible for informing themselves in preparing their proposal. SECTION 5. TERMS OF REFERENCE

BACKGROUND

In 2024 – 2027, UNDP and UNICEF jointly implement the “Advancing Quality Education and Lifelong Learning Opportunities for All” programme funded by the European Union. The programme's overarching objective is to contribute to human capital development in the Republic of Moldova, improving the quality and relevance of education and lifelong learning opportunities for all to match the labour market demands better. To achieve this, the Programme will target the following specific objectives:

1. Strengthen institutions and systems for teacher and school leader professional development and support the implementation of education policies to enhance the quality of teaching and learning (Development Strategy “Education 2030”).
2. Improve equitable access for all children to quality education, promoting the development of an inclusive, digital, and resilient education system.
3. Upgrade learning environments by renovating selected school infrastructures and facilitating the development of 21st-century skills, contributing to better education opportunities for pupils and students and improved efficiency of the school network.

Under this joint Project, UNDP will support the Ministry of Education and Research to ensure equitable access for all children to quality education and, therefore, to schools, particularly in rural areas and less accessible communities.

In the Republic of Moldova, managing school transportation involves multiple stakeholders: educational institutions, local public authorities, and the Ministry of Education and Research. The current challenges they face are the lack of a centralized system for real-time tracking of school buses, difficulties obtaining detailed reports on resource usage and compliance with regulations, and insufficient coordination among parents, administrators, and drivers, impacting trust in transportation services.

To address these challenges, the Ministry of Education and Research intends to benefit from fleet monitoring services based on an existing market solution offered via subscription. These services will significantly improve school transportation management's safety, efficiency, and transparency.

The to-be-procured fleet monitoring services must adhere to national regulations and standards governing student transportation, including:

- Government Decision No. 903/2014: approves the regulation on student transportation, establishing rules for organizing and conducting school transportation.
- 2024 Amendments: updates rules for student transportation, ensuring access to quality education and improving school bus transport regulations.
- Order no. 292A of 28 September 2023 establishes measures for transporting children and students for the 2023–2024 academic year.

By implementing these services, the Ministry of Education and Research and local authorities can ensure safer, more efficient, and transparent student transportation, supporting educational objectives and improving public service quality.

SCOPE OF WORK AND OBJECTIVES

This assignment aims to procure ready-to-use information services for 455 school buses to monitor school transportation through modern functionalities over a period of 21 months (September 2025 – May 2027). The services will be procured by UNDP Moldova but subscribed to the school bus owners/administrators and to the Ministry of Education and Research.

The school bus fleet varies in size and ownership from district to district. There are five types of school bus ownership: the Ministry of Education and Research, the District Council (Consiliul Raional), the Department of Education within the District Council (Direcția Învățământ, Tineret și Sport/Direcția Generală Educație), Local Public Authorities (Primaria), and school.

In most cases, the buses belong to the Department of Education within the District Council; however, many schools also own and manage buses directly. The body that owns the buses is responsible for route planning and daily monitoring of the buses, drivers, and transported students and will be the primary user of the fleet monitoring services, with some exceptions, such as the Ministry of Education and Research, which may own buses, but will not be responsible for their daily management.

School buses pick up students from various rural locations and transport them (from home/pick-up/drop-off points) to their respective schools and back, especially those who study outside their village/commune/city, with a radius of up to 35-50 km.

Therefore, the assignment aims to transform school transportation into a safer, more efficient, and more transparent process, supporting public authorities, educational institutions, and parents. The digital services to be purchased through this assignment will achieve the goals described above through the functionalities described below:

I. Real-time bus monitoring

This feature allows users with corresponding rights to monitor the movement of school buses in real time.

Bidders should offer options for bus monitoring via GPS. This will allow real-time vehicle position monitoring, providing accurate and reliable data on their position, speed, stops, and travelled distance.

- **GPS monitoring:** This involves installing a dedicated GPS device in the bus for the duration of the contract, which constantly transmits vehicle coordinates to the central server. The device must be robust and ensure continuous transmissions without interruption, providing accurate vehicle location data at all times.
- **Monitoring on map:** All users of the solution, such as administrative staff, drivers, and representatives of the Ministry of Education and Research, will be able to visualize the bus's location in real time on an interactive map available in the web portal/application. This portal should be easily accessible and provide frequent updates of the bus's location.

II. Driver management

The procured services should allow driver management, including registration, monitoring, and assigning drivers to routes.

- **Driver registration:** Each driver must be registered in the system by the administrator.
- **Driver assignment to buses:** The solution administrators will manually assign drivers to buses and related routes according to availability and operational needs.
- **Driver performance monitoring:** each driver's activity, including route adherence and driving time, speed, shall be monitored to ensure legal compliance and operational efficiency.

III. Route planning and adjustment/optimization

The procured services should allow for the creation and adjustment/optimization of bus routes according to the number of students and pick-up and drop-off points.

- **Route creation and adjustment/optimization:** Administrators will be able to configure bus routes based on the system's data and modify them in real time if necessary.

IV. Fuel consumption monitoring

The procured services should allow for monitoring fuel consumption. Each vehicle will have the necessary GPS equipment installed in the bus to facilitate fuel consumption monitoring. The fuel consumption data will be used for reporting purposes.

Fuel consumption can be monitored using formulas based on the distance and average consumption of the vehicle. The distance of the route will be calculated based on the map monitoring; each vehicle's average consumption will be introduced manually in the system.

- **Implementation details:** each bus will have an updated fuel consumption log.
- Fuel consumption data will be used in vehicle financial and performance reports.

V. Generation and storage of waybills

The procured services shall be able to automatically generate waybills for each bus and store them for one year (12 months).

- **Automatic generation:** The services should automatically generate detailed waybills based on data about planned routes and students transported.
- **Storage and archiving:** The services should archive the waybills for one year, as required by law, allowing easy access for subsequent audits or verifications.

VI. Reporting and analytics

The services will allow for generation of detailed reports including the following fields:

- Owner
- Educational institution
- Locality
- Car ID
- Car Model
- Driver
- Mileage
- Average Fuel Consumption per 100 km
- Consumed Fuel

The services will allow for generation of detailed reports for the following time periods:

- 1 day
- 1 week
- 1 month
- 3 months
- 1 year
- Custom period set by users with corresponding rights.

Additionally, the service will allow for the generation of customized report, such as:

- **Custom reports:** Fuel efficiency, route efficiency, driver behavior reports, attendance records, etc.
- **Data dashboard:** Visual analytics and KPIs for school administrators and the Ministry of Education.

VII. Integration and interoperability

- **API for future enhancements:** Allow future systems to interact with the fleet management solution.

VIII. User access and permissions

- **Role-based access:** Different permissions for Ministry officials, school admins, bus owners, and parents.
- **Data privacy compliance:** Ensure compliance with appropriate data protection regulations in force in the Republic of Moldova.

IX. Connectivity and offline mode

- **Offline data sync:** If internet connectivity is lost, the services should continue collecting data and sync when back online.

X. Maintenance and support

The procured services will ensure continuous and efficient operation of fleet monitoring services, minimizing downtime and disruptions through:

- 24/7 support for troubleshooting and resolving issues;
- Provision of the latest software updates;
- Inspection and repair of hardware components as needed;
- Ongoing training for staff on system usage and best practices.

The services will include hardware maintenance and support, ensuring that tracking devices and/or other digital equipment are properly serviced and functional. This includes regular diagnostics, troubleshooting, and replacement of faulty hardware components.

The bidders must provide free access to a demo application as part of the evaluation process. Failure to do so may result in the disqualification of the bidder. The access link and credentials must be indicated in the Technical Proposal.

Project Stakeholders and Roles

Implementing the services described in the scope of work involves close collaboration among several stakeholders, each playing a specific role in its use, administration, and supervision.

Drivers, representatives of local public authorities and educational institutions (schools) will be the primary users of the services. Their administrators will use the services for route planning, managing buses, and daily monitoring of student transportation. The schools will also provide data about the transported students and their pickup/drop-off points.

- **Bus drivers** will use the services to follow planned routes, log daily activities, and report any incidents or deviations. The services will help simplify their administrative tasks and create a more organized work environment.
- **Local Public Authorities** organize and finance school transportation in their communities. The fleet monitoring solution allows them to monitor resource usage, access detailed reports on distances, speed, stops, and make informed decisions to improve services.
- **Representatives of the Ministry of Education and Research** will have access to all information within the fleet monitoring portal, and particularly to the routes and reports generated by the solution. The Ministry will use the portal to monitor and evaluate the performance of school transportation, ensuring compliance with national regulations.

Training of Trainers and Users

The Bidder shall offer one **one-day in-person training session** and three online sessions for the service users described in the project stakeholders, according to the timeline in the Deliverables section. The Bidder shall also develop and present to the Contractor a text or video guide on how to use the functionalities of the services.

The one-day training session on using the bus tracking services and equipment and fleet monitoring solution will be provided in person and onsite in Chisinau for around 40 persons in total (representatives of the local public authorities and MER). Venue and catering costs will be covered by UNDP and/or the Beneficiary. The exact location will be determined later by the project stakeholders and in consultation with the bidder.

The three online training sessions (with the same content) on using the bus tracking services and equipment and fleet monitoring solution will be provided online by the bidder to a broader audience of around 500 persons, including drivers, school managers, local public authorities, MER representatives, etc. The Bidder will space the training sessions in such a way that the afore-mentioned project stakeholders will be able to choose and join at least one of the online training sessions.

Training sessions subjects:

- Monitoring technology hardware and software (GPS);
- Registration, assignment, and change of drivers;
- Route planning, modification and optimization;
- Monitoring fuel consumption hardware and software;
- Live map and web portal view and management;
- Report generation;
- Security protocols;
- Troubleshooting and support;
- Others, if needed.

The provided training ensures that service users and administrators are fully equipped to manage the solution efficiently and effectively.
