Question 1: What is the maximum percentage from the grant amount or the procurement of equipment? **Answer:** There is no established limit for the procurement of the equipment.

Question 2: What is the area coverage of the project? **Answer:** The area coverage of the project is the city of Chisinau.

Question 3: Regarding the procurement of the equipment? **Answer:** Along with the procurement of the equipment, the company should focus on the project results bringing benefits to the Chisinau communities.

Question 4: The grant amount being too small, can not bring visible results at higher level. **Answer:** The expectations are that these small grants to boost the start of small businesses, a kind of start-up, with a potential for replicability, scalability.

Question 5: Are applicable the projects that reduce harmful emissions? **Answer:** Both projects that reduce greenhouse gas emissions and those that reduce emissions of harmful gases are welcome.

Question 6: Is it possible to interconnect a potential project with the air quality measurement sensors project? **Answer:** Any collaboration between projects is welcome. If the idea of the new project contributes to reducing emissions of harmful gases and CO_2 . it is also welcome. In the event of selecting the potential proposal, support will be provided in establishing a collaboration between the new initiative with the already existing one.

Question 7: What can be the maximum amount of the implemented project? **Answer:** There is no limit to the maximum amount of the implemented project. Irrespective of its maximum amount, the grant amount will be \$ 8,000. The amount of the co-financing will be at least 30% of the project value.

Question 8: Can the NGO be an applicant?

Answer: The NGO can not be a candidate under the Fast Track Challenge program but can come in partnership with a private entity that will apply for the grant. Moreover, NGOs can create private entities. It is also encouraged the partnership with different subdivisions, municipal departments, municipal enterprises.

Question 9: What is the implementation time of the project? **Answer:** The implementation time of the project is 9 months.

Question 10: How is the grant allocated?

Answer: Funding is granted in 2 installments: the first tranche of 70% of the grant amount and the second one – 30% after the project implementation.

Question 11: How will the co-financing be presented?

Answer: Co-financing may be monetary and / or in-kind. If the applicant has several projects in implementation, it can be shown as co-financing, including activities from other projects, as long as they relate to the areas of interest of the Fast Track Challenge, complement each other and do not overlap.

Question 12: How does zero VAT apply?

Answer: VAT zero rate applies only to grant, not to the amount of co-financing.

Question 13: Will the Applicant Organization's experience be taken into consideration? **Answer:** The experience per partnership will be taken into account. At the same time, we mention that this competition is a contest of ideas, focusing on their sustainability.
