# **Section 2.** Instruction to Bidders

GENERAL PROVISIONS				
1. Introduction	1.1	Bidders shall adhere to all the requirements of this ITB, including any amendments made in writing by UNDP. 	1.2	Any Bid submitted will be regarded as an offer by the Bidder and does not constitute or imply the acceptance of the Bid by UNDP. UNDP is under no obligation to award a contract to any Bidder as a result of this ITB.		
	1.3	UNDP reserves the right to cancel the procurement process at any stage without any liability of any kind for UNDP, upon notice to the bidders or publication of cancellation notice on UNDP website.		
	1.4	As part of the bid, it is desired that the Bidder registers at the United Nations Global Marketplace (UNGM) website ( <a href="www.ungm.org">www.ungm.org</a> ). The Bidder may still submit a bid even if not registered with the UNGM. However, if the Bidder is selected for contract award, the Bidder must register on the UNGM prior to contract signature.		
2. Fraud & Corruption, Gifts and Hospitality	2.1	UNDP strictly enforces a policy of zero tolerance on proscribed practices, including fraud, corruption, collusion, unethical or unprofessional practices, and obstruction of UNDP vendors and requires all bidders/vendors observe the highest standard of ethics during the procurement process and contract implementation. 3. Eligibility	3.1	A vendor should not be suspended, debarred, or otherwise identified as ineligible by any UN Organization or the World Bank Group or any other international Organization. Vendors are therefore required to disclose to UNDP whether they are subject to any sanction or temporary suspension imposed by		

these organizations. 3.2 It is the Bidder's responsibility to ensure that its employees, joint venture members, sub-contractors, service providers, suppliers and/or their employees meet the eligibility requirements as established by UNDP. 4. Conflict of Interests 4.1 Bidders must strictly avoid conflicts with other assignments or their own interests, and act without consideration for future work. Bidders found to have a conflict of interest shall be disqualified. Without limitation on the generality of the above, Bidders, and any of their affiliates, shall be considered to have a conflict of interest with one or more parties in this solicitation process, if they: a) Are or have been associated in the past, with a firm or any of its affiliates which have been engaged by UNDP to provide services for the preparation of the design, specifications, Terms of Reference, cost analysis/estimation, and other documents to be used for the procurement of the goods and services in this selection process; b) Were involved in the preparation and/or design of the programme/project related to the goods and/or services requested under this ITB; or c) Are found to be in conflict for any other reason, as may be established by, or at the discretion of UNDP. 4.2 In the event of any uncertainty in the interpretation of a potential conflict of interest, Bidders must disclose to UNDP, and seek UNDP's confirmation on whether or not such conflict exists. 4.3 Similarly, the Bidders must disclose in their Bid their knowledge of the following: If the owners, part-owners, officers, directors, controlling shareholders, of the bidding entity or key personnel who are family members of UNDP staff involved in the procurement functions and/or the Government of the country or any Implementing Partner receiving goods and/or services under this ITB; and b) All other circumstances that could potentially lead to actual or perceived conflict of interest, collusion or unfair competition practices. Failure to disclose such an information may result in the rejection of the Bid or Bids affected by the non-disclosure. 4.4 The eligibility of Bidders that are wholly or partly owned by the Government shall be subject to UNDP's further evaluation and review of various factors such as being registered, operated and managed as an independent business entity, the extent of Government ownership/share, receipt of subsidies, mandate and access to information in relation to this ITB, among others. Conditions that may lead to undue advantage against other Bidders may result in the eventual rejection of the Bid. **B. PREPARATION OF BIDS** 5. General 5.1 In preparing the Bid, the Bidder is expected to examine the ITB in detail. Material Considerations deficiencies in providing the information requested in the ITB may result in rejection of the Bid. 5.2 The Bidder will not be permitted to take advantage of any errors or omissions in the ITB. Should such errors or omissions be discovered, the Bidder must notify

the UNDP accordingly.

6. Cost of Preparation of Bid	The Bidder shall bear all costs related to the preparation and/or submission of the Bid, regardless of whether its Bid is selected or not. UNDP shall not be responsible or liable for those costs, regardless of the conduct or outcome of the procurement process.
7. Language	7.1 The Bid, as well as any and all related correspondence exchanged by the Bidder and UNDP, shall be written in the language (s) specified in the BDS.
8. Documents Comprising the Bid	8.1 The Bid shall comprise of the following documents and related forms which details are provided in the BDS:

9. Documents Establishing the Eligibility and Qualifications of the Bidder	The Bidder shall furnish documentary evidence of its status as an eligible and qualified vendor, using the Forms provided under Section 6 and providing documents required in those forms. In order to award a contract to a Bidder, its qualifications must be documented to UNDP's satisfaction.
10. Technical Bid Format and Content	10.1 The Bidder is required to submit a Technical Bid using the Standard Forms and templates provided in Section 6 of the ITB.
	10.2 Samples of items, when required as per Section 5, shall be provided within the time specified and unless otherwise specified by the Purchaser, at no expense to the UNDP. If not destroyed by testing, samples will be returned at Bidder's request and expense, unless otherwise specified.
	10.3 When applicable and required as per Section 5, the Bidder shall describe the necessary training programme available for the maintenance and operation of the equipment offered as well as the cost to the UNDP. Unless otherwise specified, such training as well as training materials shall be provided in the language of the Bid as specified in the BDS.
	10.4 When applicable and required as per Section 5, the Bidder shall certify the availability of spare parts for a period of at least five (5) years from date of delivery, or as otherwise specified in this ITB.
11. Price Schedule	11.1 The Price Schedule shall be prepared using the Form provided in Section 6 of the ITB and taking into consideration the requirements in the ITB.
	11.2 Any requirement described in the Technical Bid but not priced in the Price Schedule, shall be assumed to be included in the prices of other activities or items, as well as in the final total price.
12. Bid Security	12.1 A Bid Security, if required by BDS, shall be provided in the amount and form indicated in the BDS. The Bid Security shall be valid for a minimum of thirty (30) days after the final date of validity of the Bid.
	12.2 The Bid Security shall be included along with the Bid. If Bid Security is required by the ITB but is not found in the Bid, the offer shall be rejected.

12.3 If the Bid Security amount or its validity period is found to be less than what is required by UNDP, UNDP shall reject the Bid. 12.4 In the event an electronic submission is allowed in the BDS, Bidders shall include a copy of the Bid Security in their bid and the original of the Bid Security must be sent via courier or hand delivery as per the instructions in BDS. 12.5 The Bid Security may be forfeited by UNDP, and the Bid rejected, in the event of any, or combination, of the following conditions: a) If the Bidder withdraws its offer during the period of the Bid Validity specified in the BDS, or; b) In the event the successful Bidder fails: to sign the Contract after UNDP has issued an award; or to furnish the Performance Security, insurances, or other documents that UNDP may require as a condition precedent to the effectivity of the contract that may be awarded to the Bidder. 13. Currencies 13.1 All prices shall be quoted in the currency or currencies indicated in the BDS. Where Bids are quoted in different currencies, for the purposes of comparison of all Bids: a) UNDP will convert the currency quoted in the Bid into the UNDP preferred currency, in accordance with the prevailing UN operational rate of exchange on the last day of submission of Bids; and b) In the event that UNDP selects a Bid for award that is quoted in a currency different from the preferred currency in the BDS, UNDP shall reserve the right to award the contract in the currency of UNDP's preference, using the conversion method specified above. 14. Joint Venture, 14.1 If the Bidder is a group of legal entities that will form or have formed a Joint Consortium or Venture (JV), Consortium or Association for the Bid, they shall confirm in their Bid that: (i) they have designated one party to act as a lead entity, duly vested Association with authority to legally bind the members of the JV, Consortium or Association jointly and severally, which shall be evidenced by a duly notarized Agreement among the legal entities, and submitted with the Bid; and (ii) if they are awarded the contract, the contract shall be entered into, by and between UNDP and the designated lead entity, who shall be acting for and on behalf of all the member entities comprising the joint venture. 14.2 After the Deadline for Submission of Bid, the lead entity identified to represent the JV, Consortium or Association shall not be altered without the prior written consent of UNDP. 14.3 The lead entity and the member entities of the JV, Consortium or Association shall abide by the provisions of Clause 9 herein in respect of submitting only one Bid. 14.4 The description of the organization of the JV, Consortium or Association must clearly define the expected role of each of the entities in the joint venture in delivering the requirements of the ITB, both in the Bid and the JV, Consortium or Association Agreement. ### **Section 5a:** Scope of Works

#### 1. BACKGROUND

The "**EU4Moldova**: **focal regions**" Programme supports the strengthening of the economic, territorial and social cohesion in the Republic of Moldova through facilitating inclusive, sustainable and integrated local socio-economic growth and improving the standards of living of the citizens in two focal regions: Ungheni and Cahul municipalities and neighboring communities. The Programme will support the two regions by: making the governance more efficient – improving the quality of services and necessary infrastructure; fostering private sector – increasing investments, improving local economy and creating jobs; encouraging participatory democracy – involving citizens in the process of democratic governance and enhancing their capacities to claim their rights.

The Programme aims to achieve the following objectives: (i) To strengthen transparency, accountability of local public authorities and citizen participation in local governance processes in the focal regions; (ii) To improve citizens' access to quality public services and utilities in the focal regions; (iii) To create employment opportunities for men and women in the focal regions and improve the attractiveness of the focal regions for investors and entrepreneurs; (iv) To promote the smart specialization of the economy of the focal regions through the development of the clustering and value chain approach in key economic sectors.

#### 2. SCOPE OF WORKS

EU4 Moldova Focal Regions Program is looking for a company/consortium that will demonstrate experience in the field of road construction in Moldova to carry out the works "Construction of dry-type

pedestrian fountain with light and music show and development of the adjacent territory in Nationala Str. – Independentei Square in mun. Ungheni", "Repair of road pavement in Nationala Str., parking lot arrangement (on the section between Romana and Stefan cel Mare Streets) in mun. Ungheni" as part of the project "Reconstruction and revitalization of Ungheni Town Centre".

# 2.1 "Reconstruction and revitalization of Ungheni Town Centre" will be implemented in the following stages:

**Stage 2 (2021)** - Reconstruction and extension of sidewalks from Romana Street to Stefan cel Mare Street (ME "Apa-Canal") with the delimitation of pedestrian and bicycle lanes and arrangement of green spaces with SMART elements and urban furniture. The technical execution project is being developed.

**Stage 3 (2022 - 2024)** - Revitalization of spaces adjacent to Nationala Street (the area between Lake Delia and Nationala Street) in accordance with the Zonal Urban Plan (energy efficiency of public buildings, promotion of decorative lighting of public buildings, landscaping, etc.)

The subject of this tender are Stages 1.1 and 1.2 listed above.

Content of the works "Construction of dry pedestrian-type fountain with light and music show and development of the adjacent territory in Nationala Str. – Independentei Square in mun Ungheni" provides for the following types of works: preparatory works (demolition of existing asphalt concrete surfaces, demolition of existing monolithic concrete foundations on the market/square surface), construction of the fountain and engineering networks for its operation, paving with vibro-pressed concrete slabs, restoration of adjacent road of Nationala Street and arrangement with street decoration elements (lighting poles, concrete benches, trees).

Content of works "Repair of road pavement in Nationala Str., parking lot arrangement (on the section between Romana Str. and Stefan cel Mare Str.) in mun. Ungheni" provides for the arrangement of car parks, landscaping works, driveway repair works, rehabilitation works of access roads to yards. All these types of works and activities will contribute, in the end, to the improvement of the living conditions of the population in mun. Ungheni and the region, beneficiaries of the EU4Moldova Focal Regions Program.

**2.2** The Contractor must ensure all the necessary elements for the successful fulfilment of the contract: labor, engineering, installations and equipment, support materials, transportation, machines and mechanisms, tools, overheads needed for carrying out all the works under this contract. Transportation of materials shall be the responsibility of Contractor. Residues formed as a result of civil works undertaken will be evacuated by the Contractor to authorized dumps.

The Contractor will be responsible for:

- procurement and delivery to the site of necessary materials, machinery, equipment, and services for successful carrying out of works;
- preparing the site so as to ensure security and storage of materials, machinery and equipment necessary for carrying out the works;
- construction and landscaping works;
- launching into operation and operating the installed networks, facilities and equipment, including carrying out performance tests and operational tests;
- for road pavement laboratory tests are mandatory and submitted to UNDP;
- provision of detailed documentation on operation and maintenance of installed objects and systems;
- commissioning of executed construction works, including performance tests (as appropriate)
- **2.3** The physical and chemical characteristics of the construction materials, proposed by the contractors, shall comply with the requirements set out in the Scope of Works as well as with the guidelines, requirements and technical specifications required below. Construction materials must have national certificates of conformity and/or European Certificates (EC), which confirm the quality indices. As well, the Contractor must ensure that all materials, equipment and activities related to construction works under the contract, to be coordinated, prior to fulfilment, with the representatives of the Beneficiary and UNDP Moldova, accountable for: daily supervision and periodical monitoring of the works on the site.

#### 3. ORGANIZATIONAL ARRANGEMENTS

The implementation of the project and the fulfilment of on-site works will be monitored by the UNDP Moldova Engineer, who will systematically visit the construction site for monitoring, and, additionally, by the Technical Supervisor/Engineer, authorized by the Local Public Authority, who will ensure daily supervision of construction works that are subject of the contract.

#### 4. EXPECTED RESULTS

The following *results* are expected from the Contractor:

**Result 1**: Completion of all construction works, provided in the contract documents, within a period not exceeding **180 calendar days**, starting from the date on which the Contractor is given Access to the Site and receives a notice from the UNDP Engineer to commence the Works and ending on the date of substantial completion of Works stated in the Certificate of Substantial Completion.

**Result 2:** Final commissioning of the object within a period of: 90 calendar days – up to 6 months, since the reception of the works finished at the site.

#### 5. MAIN TECHNICAL REQUIREMENTS AND SPECIFICATIONS

Execution of construction and landscaping works will be performed in accordance with the provisions of

#### the following documents:

- technical design documentation no.02/20 "Construction of the dry-type pedestrian fountain with light and music show and development of adjacent territory in Nationala Str. Independentei Square in mun. Ungheni", developed in March 2020 based on the Urbanism Certificate no. 805/18 of 12.12.2018,
- technical design documentation no. 204/20-D "Repair of road pavement in Nationala Str., parking lot arrangement (on the section between Romana Str. and Stefan cel Mare Str.) in mun. Ungheni" developed in December 2020 based on the Urbanism Certificate no. 96 of 11.12.2020 and
- the technical design documentation no. 205/2019-P "Arrangement of parking lots in the central area of Ungheni (Alexandru cel Bun Str. and Mihai Eminescu Str.)" based on the Urbanism Certificate no. 97 of 11.12.2020.

The above-mentioned technical designs have been developed, approved and verified in the manner established by regulatory documents on constructions in force (as per Annex 3 to the ITB).

The following works must be performed:

#### **Preparatory works:**

- Restoring the route and picketing the axis;
- Demolition of existing indicators;
- Demolitions: curbs, existing concrete foundations;
- Transportation of construction waste, resulting from demolition, at a distance of about 5 km to a storage place established by the City Hall of Ungheni.

# Construction of the fountain and development of the adjacent territory on Nationala Str. – Independentei Square:

- Earthworks, construction of monolithic reinforced concrete resistance structure, waterproofing, installation of terracotta;
- Electrical and technical-sanitation works;
- External water supply and sewerage networks;
- External power supply networks;
- Pavement installation: "Brick" type vibro-pressed concrete (10cm x 20cm), grey and white colour with granite surface, "Square" type vibro-pressed concrete (10cm x 10cm), grey and white colour with granite surface, at least 135 kg/m2, thickness 6 cm;
- Landscaping (lighting fixtures, planting trees, installing benches)
