# **Section 2.** Instruction to Bidders

A. GENERAL PROVISIONS			
1. Introduction	1.1	Bidders shall adhere to all the requirements of this RFP, including any amendments in writing by UNDP. 	1.2	Any Proposal submitted will be regarded as an offer by the Bidder and does not constitute or imply the acceptance of the Proposal by UNDP. UNDP is under no obligation to award a contract to any Bidder as a result of this RFP.	
	1.3	As part of the bid, it is desired that the Bidder registers at the United Nations Global Marketplace (UNGM) website ( <a href="www.ungm.org">www.ungm.org</a> ). 2. Documents Establishing the Eligibility and Qualifications of the Bidder	9.1 The Bidder shall furnish documentary evidence of its status as an eligible and qualified vendor, using the Forms provided under Section 6 and providing documents required in those forms. In order to award a contract to a Bidder, its qualifications must be documented to UNDP's satisfaction.	
10.Technical Proposal Format and Content	10.1 The Bidder is required to submit a Technical Proposal using the Standard Forms and templates provided in Section 6 of the RFP.	
	10.2 The Technical Proposal shall not include any price or financial information. A Technical Proposal containing material financial information may be declared non-responsive.	
	10.3 Samples of items, when required as per Section 5, shall be provided within the time specified and unless otherwise specified by UNDP, and at no expense to UNDP	
	10.4 When applicable and required as per Section 5, the Bidder shall describe the necessary training programme available for the maintenance and operation of the services and/or equipment offered as well as the cost to the UNDP. Unless otherwise specified, such training as well as training materials shall be provided in the language of the Bid as specified in the BDS.	
11.Financial Proposals	11.1 The Financial Proposal shall be prepared using the Standard Form provided in Section 6 of the RFP. It shall list all major cost components associated with the services, and the detailed breakdown of such costs.	
	11.2 Any output and activities described in the Technical Proposal but not priced in the Financial Proposal, shall be assumed to be included in the prices of other activities or items, as well as in the final total price.	
	11.3 Prices and other financial information must not be disclosed in any other place except in the financial proposal.	
12.Proposal Security	12.1 A Proposal Security, if required by BDS, shall be provided in the amount and form indicated in the BDS. The Proposal Security shall be valid up to thirty (30) days after the final date of validity of the Proposal.	
	12.2 The Proposal Security shall be included along with the Technical Proposal. If Proposal Security is required by the RFP but is not found along with the Technical Proposal, the Proposal shall be rejected.	
	12.3 If the Proposal Security amount or its validity period is found to be less than what is required by UNDP, UNDP shall reject the Proposal.

Currencies 13.1 All prices shall be quoted in the currency or currencies indicated in the BDS. Where Proposals are quoted in different currencies, for the purposes of comparison of all Proposals: a) UNDP will convert the currency guoted in the Proposal into the UNDP preferred currency, in accordance with the prevailing UN operational rate of exchange on the last day of submission of Proposals; and b) In the event that UNDP selects a proposal for award that is quoted in a currency different from the preferred currency in the BDS, UNDP shall reserve the right to award the contract in the currency of UNDP's preference, using the conversion method specified above. 14. Joint Venture. 14.1 If the Bidder is a group of legal entities that will form or have formed a Joint Venture (JV), Consortium or Association for the Proposal, they shall confirm in Consortium or their Proposal that: (i) they have designated one party to act as a lead entity, Association duly vested with authority to legally bind the members of the JV, Consortium or Association jointly and severally, which shall be evidenced by a duly notarized Agreement among the legal entities, and submitted with the Proposal; and (ii) if they are awarded the contract, the contract shall be entered into, by and between UNDP and the designated lead entity, who shall be acting for and on behalf of all the member entities comprising the joint venture. 14.2 After the Deadline for Submission of Proposal, the lead entity identified to represent the JV, Consortium or Association shall not be altered without the prior written consent of UNDP. The lead entity and the member entities of the JV, Consortium or Association shall abide by the provisions of Clause 9 herein in respect of submitting only one proposal. 14.4 The description of the organization of the JV, Consortium or Association must clearly define the expected role of each of the entity in the joint venture in delivering the requirements of the RFP, both in the Proposal and the JV, Consortium or Association Agreement. 	14.7 JV, Consortium or Associations are encouraged for high value, multi-sectoral requirements when the spectrum of expertise and resources required may not be available within one firm.
15.Only One Proposal	15.1 The Bidder (including the individual members of any Joint Venture) shall submit only one Proposal, either in its own name or as part of a Joint Venture.

17.Extension of Proposal Validity Period	17.1 In exceptional circumstances, prior to the expiration of the proposal validity period, UNDP may request Bidders to extend the period of validity of their Proposals. The authorization shall be communicated through a document evidencing such authorization issued by the legal representative of the bidding entity, or a Power of Attorney, accompanying the Proposal. 22.3 Bidders must be aware that the mere act of submission of a Proposal, in and of itself, implies that the Bidder fully accepts the UNDP General Contract Terms and Conditions. The EU4Moldova: Focal regions Programme (further on referred as Programme) is based on the European Commission Implementing Decision on the Annual Action Programme 2018 in favour of the Republic of Moldova and is funded by the European Union and implemented by the United Nations Development Programme and United Nations Children's Fund.

The overall objective of the five-year Programme is to strengthen the economic, territorial and social cohesion in the Republic of Moldova through smart, green, inclusive, sustainable and integrated local socio-economic growth as well as by improving the standards of living of the citizens in the focal regions of Cahul and Ungheni.

To this end, this Programme will address also the urban-rural divide as well as regional disparities, stimulate economic growth and job creation, refurbish and upgrade some social and technical infrastructure in selected areas (smaller towns and villages) while taking into account climate change and a gender perspective in the activities of the Programme.

#### **Specific context**

Both focal regions will receive important capacity building assistance to support the implementation and monitoring of local economic development plans and will benefit of investment funding in support of the creation and/or development of social and technical infrastructure.

The Programme also aims to support reconstruction/beautification of the urban centres of Cahul and Ungheni. This intervention will create a strong visual impact for the development agenda of the focal regions – this will give the idea of 'emerging strong regional growth poles' committed to change their current status of 'declining periphery'.

In this regard, the Programme will assist the promotion of the created Brand (for Each Focal Region) based on the comparative advantages, local economic potential, inspirational and core values. The connected activity is implementation of highly visible and flamboyant projects of beautification and architectural redesign of urban centres. The image, story and slogans as well modernized city centres are to be promoted through a strategic communication campaign. The goal of the campaign is to improve domestic and international perception of Cahul and Ungheni focal regions – as two most dynamic Moldovan regions in promoting development and economic growth. The brand identity will be central to the communication plan and through it the regions will seek to convey an accurate sense of what makes Cahul and Ungheni unique.

A region's brand will be an extension of its reputation for every aspect of region's life: social, economic, cultural, touristic etc. The brand's value will be enhanced by the positive experiences of citizens, investors, visitors, and all those observing the changes in Cahul and Ungheni regions.

The brand is to have a strong economic development context and because of a massive information and promotion campaign, the brand will be associated to the qualities/ characteristics of the region. This major intangible asset will attract investors, tourists, and talents to the emerging Growth Poles in Cahul and Ungheni. The openness for business activities, the pragmatic public administration, the success stories of both business and people development, urban legends arousing interest to local exploration, the digital transformation journey of the regions will enhance the brand formation and shape the future of the Regions.

#### C. SCOPE OF WORK

The EU4Moldova: focal regions Programme (hereinafter the Programme) is looking for a Company (hereinafter Contractor) to promote, during the first promotion year period (2021-2022), an integrated branding campaign – containing logos, core values for Brand and Marketing Strategy implementation, in order to advance the two Focal Regions (Ungheni and Cahul) economic, social and cultural achievements, promote their success stories, nationally and internationally. The selected Contractor will be building capacities among local target stakeholders to enhance the image of the regions, to capitalize the advantages of the regions, and to actively promote the new branding, success stories, regions development agenda through the most effective communication channels, national/international events, business for and other relevant communications channels and tools.

By presenting the brand consistently, the Programme can positively influence how people think and feel about the Focal region and amplify their impact. A strong brand will help grow the reputation, build community through shared connections, motivate audiences to visit the main attractions, support and partner with the focal regions, create passion and loyalty for continued growth and success, increase visibility and recognition locally, nationally and internationally.

In promoting Brand and Marketing Strategy, the Contractor shall consider aspects related to gender equality, human rights and non-discrimination principles as well as green and circular economy issues

#### **KEY ACTIVITIES AN EXPECTED OUTPUTS**

The Contractor shall take full responsibility for the execution and delivery of the following tasks and outputs to achieve the objectives of the assignment (**for each of two focal regions**) as described below:

#### 1. Project Initiation (Both Focal regions):

- Adapt concept of brand promotion
- Provide detailed work plan and timeline of activities.

### 2. Study Tour Organization (Both Focal regions):

- Organization of 4 Study tours per each Focal Region for influencers, journalists, famous persons visiting the landmarks and potential tourists' attractions, successful businesses, and SCO's. Study tour will aim to present each Focal Region, underlining their local uniqueness, discovering local attractiveness through architecture, cultural and historical heritages, traditions, leisure and recreation opportunities, and art of cooking, local business opportunities, best social and private practices, etc. The company will be responsible to:
- Provide list of candidates to participate to the study tours. The final list will be agreed in common with the Programme. Ensure at least 2 participants/influencers per each tour.
- Elaborate detailed concept and action plan for each tour: develop and plan itineraries for the tours (at least 5 locations per each tour). List of locations to be agreed with the Programme.
- Travel means, lodging, meals (local facilities), activities & communications with relevant actors will be covered by the Contractor. Duration of each tour two days one night.
- Ensure minimum 3 social media posts per day from each influencer related to the objective of the study tour. These posts should incorporate video, photo, live interventions, etc.
- Promote the study tours in media: ensure participation in national and local TV Programmes (at least 2 national TV programmes, media interviews and reportages per each study tour), radio (minimum 3 radio products developed per each study tour), web portals (2 stories per each tour).
- Develop Report on social media & media coverage for the tours.
- 3. **Inspirational video challenge (Both Focal regions)**. Launch a social media and media challenge to promote the brand: invite people (locals, diaspora, focal-regions lovers) to make short videos with themselves in proximity of brand symbol created by themselves (drawn on wall, paper, on air, by human bodies etc).
  - Develop the concept of the video challenge and promotion plan for the activity

- Design all visuals: social media banners, testimonials (at least 3 banners and 5 testimonials per each region)
- Promote the challenge in social media (at least 2 informative posts per day in social media & shares of video made part of the campaign on relevant pages, groups; minimum 100 000 total reach)
- Ensure at least 30 participants videos per each Focal Region
- Develop a video per region complying received video into one video spot, up to 2.20 minutes, including royalty free music, video graphics insertion, voice over in Romanian and subtitles into RO, RU and EN. Boosting in social media 100 000 Reach.

The videos will focus on exploring the people's perspective on how do they "feel and live" their Regions Brand – "Discover how to create and integrate a regional brand and involve" hundreds" of people in the process of its discovery and promotion".

  - One-day social media account takeover A series of takeovers (5 per Region) of the region's Instagram account for a day, when the account is managed by a person, local celebrity or by an influencer. During these takeovers, the guest will share, for a day, beautiful things about this region from his point of view. These takeovers can also have a specific topic.
  - Regional opportunities. A series of posts (5 per Region) dedicated to business prospects in the Ungheni and Cahul regions. These can be about a successful local company, an international investor, areas of investment and the benefits of starting a business in this region. The company will be responsible to:
    - Elaborate detailed concept and action plan of the contest
    - Promote regional opportunities for each Focal Region
  - **Foodology** A series of posts (5 per Region) about local dishes with a brief description. Some of them can also be prepared with a local chef during a live streaming on social media. The company will be responsible to:
    - Elaborate detailed concept and action plan of the contest
    - Promote foodology contest for each Focal Region
  - #ProdusUngheni #ProdusCahul. A series of posts (5 per Region) dedicated to local farmers and artisans. Each post will contain a brief description and details on how the products can

be purchased. This type of content will not only promote the region as one that cares about small local businesses, but also as a region with organic products. The company will be responsible to:

- Promote #ProdusUngheni #ProdusCahul for each Focal Region
- Realize 5 posts per week of the contest for each Focal Region
- o **Boosting.** All social media promotion events should register 150 000 Reach
- 5. Art contest (Both Focal regions). The aim is to create a simple contest, in which the community is invited to download the outline of the logo of the region to customize it with any desired technique, according to the positioning. Participants can be of any age. The only limitation is to not apply sinister or indecent designs. All works are exposed to an open vote on the social media page of the region. The public vote defines top 5 candidates, from which a committee chooses 1 to be painted as murals on the visible walls of the city. This type of contest can be promoted on social and local media, among local influencers and the creative community. The company will be responsible to:
- Elaborate detailed concept, general criteria and action plan of the contest
- Promote, moderate and interact with potential participants of the art contest for each Focal Region
- Assure at least 100 participants for each Focal Region
- Realize 5 posts per week of the contest for each Focal Region
- Organize and ensure platform for open voting procedure to identify top 5 candidates
- Set dedicated committee for top 3 winners' nomination
- Announce the art contest winners for each Region.
- **6.** Mural implementation (Cahul Focal Region). As a result of art contest, the Contractor should realize:
- Identification of location with local authorities
- Identification of best way to execute the mural image selected during the art contest
- Analyses of surface and identification of the technical solution
- Obtaining necessary authorizing documents
- Execution of mural, filming and editing making-of video (2.20 minutes max for each region)
- Launch ceremony organization: identification of participants (number of audiences to be determined depending on pandemic situation in the Country; agenda elaboration; broadcasting to Privesc.eu; hiring moderator; sound and lighting equipment, safety measures (disinfectant, safety distance)

Since the consumers' perceptions of regional products assortment and merchandising have a direct impact on retailer's local image the purpose of this activity is to develop two promotional regional products (one per each Region), aiming to underline the uniqueness of architectural heritage. For Cahul Region the contractor will identify the most expressive mosaic drawings and will create Mosaics puzzle (a mosaic image cut in shape of puzzle). For Ungheni Region, the contractor will identify the most expressive landscape/monument and will create an image cut in shape of puzzle.

8. **Photo production for each region (Cahul and Ungheni)**. The aim is to organize 5 days shootings (for each Region). Each working day should result into 100 portraits, reportages, nature/landscape photos.
